

## Children's Long-Term Supports: Regional Assignments and Contact Lists

This document contains information regarding regional and topical assignments for Children's Services Specialists (CSS). There are some specific topics handled by one individual statewide. - ❖ Contact the assigned CSS indicated for your county on this map for all issues related to children receiving, applying for, or already waiting for CLTS Waiver services.

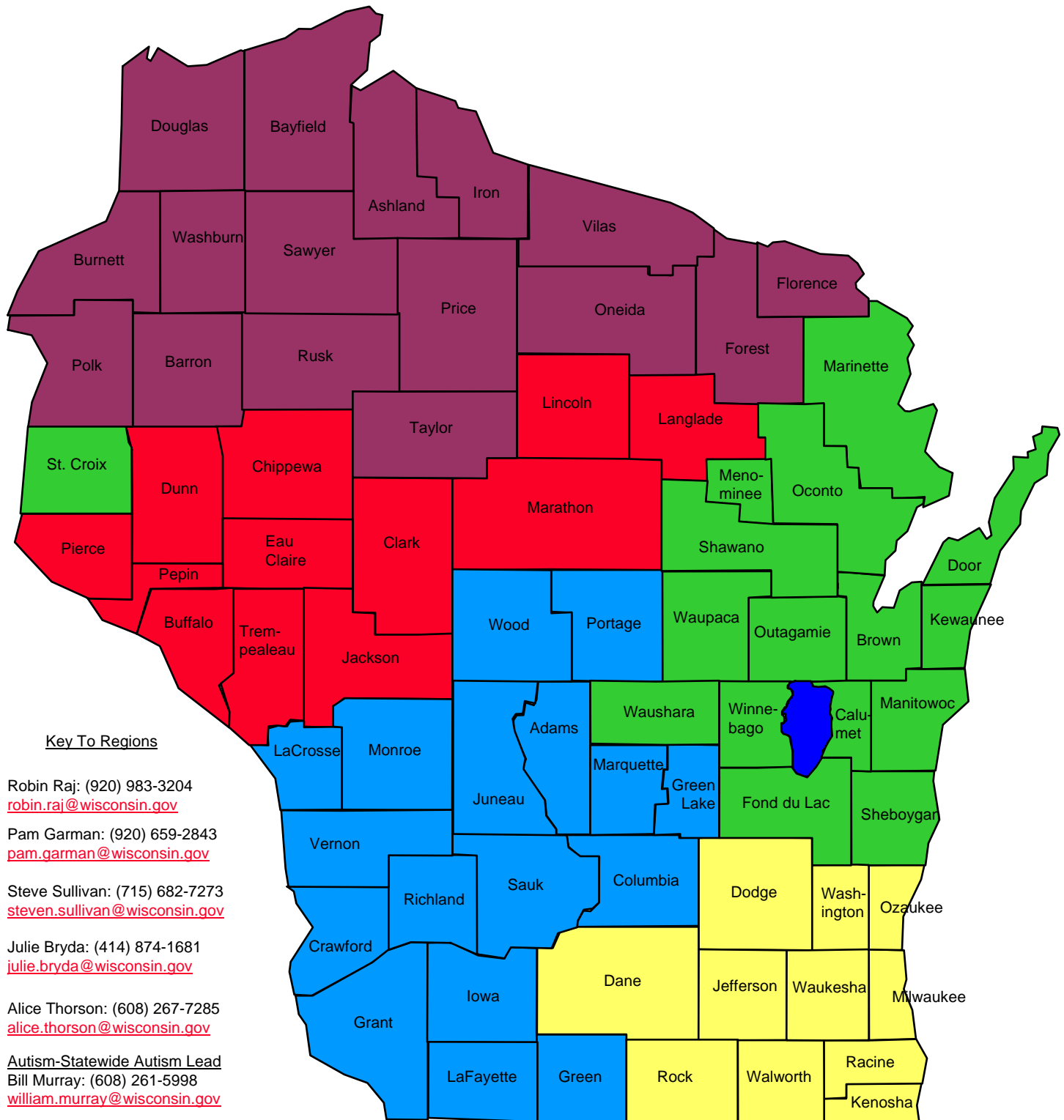

### Specific Topical Areas and Whom to Contact:

- ⇒ **Autism Intensive Treatment Services and Behavioral Consultation:** Contact Bill Murray at [william.murray@wisconsin.gov](mailto:william.murray@wisconsin.gov), or 608-261-5998, for issues related to intensive autism services, statewide waitlist, diagnostic reviews, or behavioral consultations.
- ⇒ **Autism Ongoing Services:** Initial requests for transition to ongoing should be sent directly to your assigned CSS. If transition is approved, submit the new ongoing ISP and Outcomes document to your CSS. **Early requests** for transition prior to the child finishing at least 2 years, 6 months of treatment should be sent to Bill Murray at [william.murray@wisconsin.gov](mailto:william.murray@wisconsin.gov).
- ⇒ **Denials or Terminations of Eligibility:** Sandy Blakeney is available to provide assistance with the processing of terminations and/or appeals. Contact Sandy with your questions by e-mail at [sandy.blakeney@wisconsin.gov](mailto:sandy.blakeney@wisconsin.gov), or call 608-261-7651. Note: for questions about *whether or not it is appropriate* to terminate a waiver participant, contact your assigned CSS.

- ⇒ **Home Modifications:** Contact your assigned CSS.
- ⇒ **Incident Reports:** Contact your assigned CSS.
- ⇒ **Foster Care and Shift Staff Treatment Foster Homes: - Request for placement and/or questions regarding shift staff treatment homes:** SSTFH Placement requires prior joint approval from DHS and from the Division of Children and Families (DCF). Direct all requests to Robin Raj at [robin.raj@wisconsin.gov](mailto:robin.raj@wisconsin.gov), or 920-983-3204. *All Step 2 applications containing foster home placement should be emailed directly to Robin Raj*
- ⇒ **Restrictive Measures issues or requests:** Contact Robin Raj at [robin.raj@wisconsin.gov](mailto:robin.raj@wisconsin.gov), or 920-983-3204.
