Proposed Data to be Reported for Common Carrier Services

Below is a list of the data the Department is considering for collection. The proposed method would be via a web based data collection instrument:

- Recipient Medicaid identification number
- Recipient last name
- Recipient first name
- Recipient middle initial
- County or Tribal agency name. [*This will be a drop-down box.*]
- Procedure code via a drop-down box. [*The potential procedure codes are listed below.*]
- Quantity/units (number of miles, meals, etc.)
- From date of service
- Through date of service
- One-Way
- Round-Trip
- Origin of trip (e.g., home). [*This will be a drop-down box.*]
- Destination of trip (e.g., hospital). [*This will be a drop-down box.*]
[*The potential origin and destination codes are listed below.*]
- Amount Paid
