

Homelessness Prevention and Rapid Re-housing Program (HPRP)

The Homelessness Prevention and Rapid Re-housing Program was created by the American Recovery and Reinvestment Act of 2009 to provide financial assistance and services to either prevent individuals and families from becoming homeless or help those who are experiencing homelessness to be quickly re-housed and stabilized. The funds under this program are intended to target two populations of persons facing housing instability: 1) individuals and families who are currently in housing but are at risk of becoming homeless and need temporary rent or utility assistance to prevent them from becoming homeless or assistance to move to another unit (prevention), and 2) individuals and families who are experiencing homelessness (residing in emergency or transitional shelters or on the street) and need temporary assistance in order to obtain housing and retain it (rapid re-housing).

The State of Wisconsin has been allocated \$17,101,862 in one-time funding for HPRP. The Division of Housing and Community Development (DHCD) is providing HPRP funds to homeless service providers through county allocations, which were derived from a formula that included poverty, unemployment, homeless and other community data. DHCD HPRP funds are not available in entitlement areas that receive HUD HPRP funds directly. These entitlement areas include the cities of Madison, Milwaukee, Racine and West Allis and the County of Milwaukee. Participating service providers are subject to performance measurement milestones.

HPRP provides assistance for services that are intentionally focused on housing – either financial assistance to help pay for housing, or services designed to keep people in housing or to find housing. HPRP services include: assistance with rental payments, security and utility deposits, utility payments, moving costs, housing relocation and stabilization services, case management, legal services, counseling and mediation.
