PURPOSE:

The purpose of this memo is to clarify permissible approved activities for Wisconsin Shares

BACKGROUND:

Chapter 1.5.0 of the Wisconsin Shares Child Care Policy Manual outlines the allowed approved activities for participation in Wisconsin Shares. In the past, Cares Worker Web (CWW) has accepted the selection of "other" as an approved activity for child care. "Other" is not an approved activity in either statute or policy. The Department of Children and Families has removed "other" as an option as an approved activity for Wisconsin Shares in CWW. This system change will go into effect on September 13, 2010.
