Cov neeg xav tau kev pab them cov kev pab tu mus ib lub sij hawm ntev yuav tau ua ntawv thov cov nyiaj uas muaj nyob hauv lub Resource Center.

Yim Ntxov Paub Txog Medicaid Yim Huab Zoo

Yog koj xav mus nyob hauv ib lub tsev laus los yog ib lub tsev muaj kev pab saib xyuas koj, nws yog ib qho tseem ceeb yuav tau paub txog cov kev pab tu mus ib lub sij hawm ntev uas tsoom fww yog tus them nyiaj. Thaum koj nyob rau qhov txiav txim siab xaiv qhov chaw nyob, yuav tau nug tias:

- Kuv puas tseem nyob tau hauv qhov chaw uas kuv xaiv yog kuv qhov chaw tau nyiaj los them ho pauv?

Nrhiav neeg pab; hu rau koj lub Resource Center hnub no.

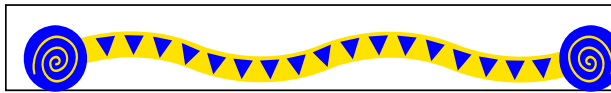


Sab Laj Muab Tswv Yim Ua Ntej

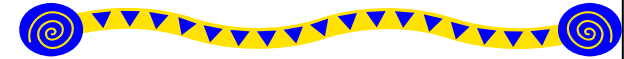
