The program provides evaluation, treatment, intensive rehabilitation and training for at risk, medically involved children and adults with intellectual disabilities. Post-operative care and treatment are provided. The length of admission may be up to 3 months.


A treatment program is developed and parent/community staff training is provided prior to discharge along with follow-up services.
