Good Morning Mike,

Thank you for your input on Wisconsin's State Plan for Assistive Technology (2018-2020). Your feedback will be shared with the Assistive Technology Advisory Council who will review the comments received and address them in the plan as appropriate. I did want to provide some background about the WisTech program and how the state plan reflects the work that WisTech is striving to achieve. WisTech provides training opportunities and technical assistance to the WisTech program subcontractors to carry out the required activities of the AT Act of 1998, as amended in 2004. In Wisconsin, the primary subcontractors to the AT program are the eight Independent Living Centers (ILCs) of Wisconsin. Activities that the ILCs will carry out as part of the AT Act include device loans, device exchanges, device reutilization, device demonstrations, and state financing. This allows individuals with disabilities, their families, and other representatives to learn about AT from specialists that work with AT on a daily basis.

You are correct that the state plan does not specifically mention augmentative and alternative communication (AAC), the goals outlined in the plan allow for the AAC knowledge base (and the AT knowledge base as a hole) to grow and develop through all of the goals identified in the plan. As an example, the training that you will be providing on July 26th will be funded with WisTech dollars; this training falls directly in line with Goal 1: Awareness (Increase awareness of assistive technology and the WisTech program) and Goal 3: Knowledge (Provide professional training opportunities through the WisTech program). The budget is not reflective of partnerships the WisTech Program has with other organizations, providers, or stakeholders.
