CLTS Council Letter:

The Autism Council discussed drafting a letter to send to the CLTS Council. The goal of the letter is to share the
Autism Council's expertise and experience about strengths and opportunities in accessing home and communitybased services through the CLTS Program.

START Initiative:

- Dan Kramarz presented on the Wisconsin Intellectual and Developmental Disabilities and Mental Health (IDD-MH) System Improvement Report, formerly known as the START Initiative.
- In 2022, the Wisconsin Department of Health Services contracted with the National Center for START Services to look at the state's service system for people who have intellectual and developmental disabilities and mental health (IDD-MH) needs. The evaluation resulted in the START Scan. The START Scan found five main areas for improvement.
- Phase 2 of the project aimed to create recommendations based on the findings of the START Scan. The goal was to
 improve supports and services for adults and children who have IDD-MH needs statewide. DHS brought together
 partners with different perspectives, experience, and expertise from around the state to form several different kinds of
 teams.
- Wisconsin IDD-MH System Improvement Report released in June 2024. The report is not created or owned by DHS.
 - Over 30 recommendations were submitted to the steering committee.
 - Eight focus areas: regional resources, expand access to psychiatric and behavioral health services, rate and billing code improvements, technology related, IDD and MH training, system review, system navigation, oversight and process improvement.

- Next steps: organize and kick off phase 3 implementation. Determine recommendations to implement and begin implementation.

Family Voices of Wisconsin, "Early Choices Matter:"

- Danielle Tolzmann presented on the Early Choices Matters: Children Building Choice-Making Skills.
- Danielle Tolzmann shared that for children with intellectual and developmental disability, practicing choice-making is
 especially important because it can lead to a more self-determined life as an adult. Everyone on the team can
 encourage a child to make choices.
 - o Let the child practice making a choice with something that will have a longer-term consequence. Narrow the options and then let the child make the final choice. Practice makes perfect.
 - An unwanted outcome can teach responsibility. Giving the child the dignity to fail, improves their choicemaking abilities.
 - o Include older children and have them be part of the team. These experiences build confidence, practice offering their choices to others, and have intentional choice-making as part of the IEP goals.
