- **Overview of Proposal to Update Bylaws**
 - Recommendations to: align with the executive order for number of members, establish term limits, and update the name of the "Support Committee" to the "Executive Planning Committee."

Updates from the Wisconsin Department of Health Services (DHS)

- **Bureau of Children's Services (BCS) – Children's Long-Term Support (CLTS) Waiver Renewal Update:**
Presentation by Zach Bauer on partner feedback regarding the CLTS Program.
 - The current waiver runs from 2022-2026 and the new waiver needs to be approved by the end of 2026; it will be in effect from 2027-2031.
 - Feedback taken from DHS offices, councils, providers, families, and counties is being distilled into actual proposals and changes to the waiver through Spring 2026. 30-Day public comment period to begin May 2026.
 - Three pillars for the waiver renewal: (1) Consistency in the CLTS experience, (2) Timely access and coordination of benefits, (3) Options for behavioral health services.
- **Presentation by Julia Thoe from the Bureau of Benefits Policy on findings from the Office of Inspector General (OIG) audit**

- Overview of how the audit was conducted.
- The audit uncovered improper payments, i.e. things that weren't allowable due to insufficient documentation to substantiate the billing.
- The Bureau of Benefits Policy plans to address three priorities: (1) Reduce the likelihood of audit findings by increasing policy compliance, (2) Benefit policy enhancements, (3) Consideration of changing service trends.

Healthcare Transitions: Tim Markle from the Waisman Center

- Presentation on transitioning autistic youth from childhood to adulthood healthcare services and better enabling them as decision makers during transition.
- Outline of the three phases of transition: (1) Birth to childhood (2) Childhood to teen (3) Teen to adult.
- Wisconsin is performing slightly better than other states in supporting these transitions, but much work is still needed.
- A greater emphasis on teaching youth how to support their own basic health needs is necessary for better transition outcomes.

Wisconsin Wayfinder Update from Michelle Lund

- Overview of the purpose and scope of Wisconsin Wayfinder.
- In the first 20 months of Wayfinder's operation:
 - 1,633 calls to the 1-800 number, with most calls from the southeastern and southern regions.
 - 2,315 online forms submitted, with 88% completed by parents/families/caregivers.
 - 3,189 unique referral contexts overall.
 - Over 9,000 information topic discussions.
 - 82% of contacts received at least one referral and over 5,500 referrals made.

Council Member Updates and Discussion

- Question from Margaret Fairbanks about current cuts to DVR and wait times.
 - The state community integrated employment initiative (CIE) workgroup is in discussions to attend future meetings and can share information at a future meeting.
- Rebecca Thompson shared a resource: thespectrum.org
- Daniel Parker recommended that all adults be encouraged to support youth in schools, not just in a technical sense, but by supporting things like a sense of belonging, activities, breaks, etc.
