Governor Evers' proposed 2021-2023 budget puts people first by increasing and improving access to health care, expanding behavioral health services, protecting our neighbors most in need, and ensuring our public health system is robust and responsive. 

- Home and Community Based Waiver Programs Rate Band Proposal

Protecting Kids

- Eliminates Children's Long-Term Support (CLTS) waitlist
- Medicaid Rate Increase for Autism Services \$22.6 million

Supporting Older Adults in the Community

- ADRC funding \$7 million
- Dementia Care Specialists \$3.5 million
- Alzheimer's Family Caregiver Support Program \$1 million

Strengthening Caregiver Workforce

- Direct Support Professional Training
- Home Care Provider Registry


