

Background Checks

Entities must conduct background checks for employees and contractors that have regular and direct contact with clients. These caregiver background checks are required at time of hire, when there is a change in circumstances and at least every four years thereafter.

Trends from On-Site Reviews

- Tracking attendance account for approved hours
- Clinical site agreements
- All skills need to be completed in lab- on an individual and dated and initialed when demonstrated to an instructor
- Teach the entire skill and not to the test
- Be sure to have policies and update and review as needed

Student File Requirements

- Skills checklist
- Attendance tracking
- Performance Record
- Course evaluation
- Health requirements complete
- Background checks complete
- Retain records for minimum of 3 years per DHS 129 - follow your policy

- QSO-24-08-NH Enhanced Barrier Precautions (EBP) Memo expired on April 28, 2025, and refers us to F880 of the SOM Appendix PP.
- EBP are used in conjunction with standard precautions
- Implementation of PPE use in NH to prevent spread of MDRO's
