Wisconsin Department of Health Services (DHS) xa tsab ntawv no tuaj faj seeb qhia koj txog ib yam hloov ntawm CLTS Waiver Program vim yog tsoom fwm teb chaws cov kev cai tswj. **Tsab ntawv no tsuas yog ncauj lus qhia koj xwb thiab koj tsis tag yuav tau raus tes ua ib yam twg.**

Muaj ib qho hloov ntawm txoj kev ntsuas cov qib nyiaj (npaum li cas) them rau qee hom kev tu xyuas thiab kev txhawb uas koj tus me nyuam tau txais. Cov qib nyiaj uas tau sib khom haum ntawm cheeb koog cov koom haum pab nyiaj thiab cov chaw muab kev pab. Vim yog tsoom fwm teb chaws cov kev cai tswj, tam sim no DHS yuav tau teeb cov qib nyiaj rau ntau cov kev pab tu xyuas ntawm CLTS .

Tsoom fwm teb chaws cov Centers for Medicare & Medicaid Services (CMS) txwv kom DHS tsim muaj cov qib nyiaj zoo sib xws thooob plaub rau qee cov kev tu xyuas ntawm CLTS . Txoj kev hloov no yuav pab kom muaj cov qib nyiaj xwm yeem thiab ncaj ncees thiab mus cuag tau cov kev pab txhawb zoo dua rau cov me nyuam uas muaj cov kev tsis taus thiab lawv cov tsev neeg.

Txoj kev hloov cov qib nyiaj rau cov kev pab cuam tsis yog yuav hloov txoj kev tsim nyog tau, cov txiaj ntsim kev pab, cheeb koog lub koom haum tam sim no, tus kws tswj xyuas kev txhawb thiab kev tu xyuas ntawm CLTS Waiver Program, los yog tej cai tam ib tug neeg tau txais CLTS Waiver.
