

### Federal Procedure Code Limitations on Claims for County Waiver Agencies

The CLTS Waiver Program has limitations on what a county waiver agency (CWA) may provide as a CLTS Waiver Program support and service per the Conflict-of-Interest Policy in the §1915(c) Waiver Application. In addition, a variety of services may be provided as a transitional support prior to enrollment. Transitional support services are authorized by the CWA and claimed by the CWA on the participant's day of enrollment.

County waiver agencies will have limitations on the Federal Procedure Codes (FPCs) they can submit claims for, based on the above policies.

The list below describes the four categories of FPCs and what outcome the CWA will receive\*.

- 1. FPCs that are allowable under the Conflict-of-Interest Policy:
  - a. May be claimed by the CWA with no limitations.
- 2. FPCs that are allowable under the Conflict-of-Interest Policy and are allowable for transitional support services:
  - a. May be claimed by the CWA with no limitations.
  - b. CWAs must use modifier indicating the use of transitional support services on the claim, when applicable.
- 3. FPCs that are allowable for transitional supports services only:
  - a. CWAs must use modifier indicating the use of transitional support services on the claim or claim will reject.
- 4. FPCs that are not allowable under the Conflict-of-Interest Policy and are not allowable transitional supports:
  - a. All claims submitted by the CWA will be rejected.
