- Council discussed creation of a caregiver risk assessment for support and service coordination
- · Recommendation for temporary revisions to respite care requirements
- Consider reimbursement to family who is unable to work and is providing replacement care for their child when outside service was not possible
- Consideration for services as resources reopen

Reflection Discussion

- Access to protective equipment for in-home care providers
- Parent-driven decision for resumption of services without loss of service when Executive Order #12 is lifted
- Concern identified for the potential financial struggles of providers through the COVID-19 crisis
- Concern identified for availability for youth to transition to adulthood in lieu of school and other community-related closures
