## **BCS Updates/News to Share**

## Waitlist Funding–Q4 2020 Plan

- Beginning in 2021, CLTS will be moving to a statewide administration of the program budget and waitlist. This will include
  a statewide system of enrollment with elimination of county-specific service allocation budgets.
- DHS will be issuing contract amendments to counties funding all children still on the waiting list.
- Waitlist Webpage (https://www.dhs.wisconsin.gov/clts/waiver/family/waitlist.htm)
  - o The council reviewed an updated webpage that showed wait length time to enrollment by each county. https://www.dhs.wisconsin.gov/publications/p02589.pdf
  - o DHS' expectation is that each county will have a consistent enrollment length time of 0-60 days.

After a county waiver agency (CWA) completes a functional screen with a child and family, the CWA enters the child's
information into the Program Participation System (PPS) statewide list; CWAs will enroll eligible children from the
statewide PPS waitlist.

- Feedback and Discussion
  - County Capacity and Infrastructure
    - DHS will be responsible for the funding and monitoring of this funding for each child enrolled. Counties will no longer make these determinations locally.
    - There was discussion regarding how county capacity to serve children will impact the new statewide enrollment process. Discussion included CWA ability to use contractors to help serve children where counties don't have the capacity to serve and CWA ability to negotiate their support and service coordination rates as a method to hire staff.
    - DHS will monitoring variability of enrollment across CWAs and address any CWA-specific situations or delays.
  - Use of the term "waitlist"
    - There were suggestions to refer to the statewide waitlist with a different terms since the new "waitlist" will be a
      continuous enrollment process as well as move away from the usage of the term "slots"; this will be addressed in future
      discussions.
  - Data Tracking
    - Some families choose to not enroll right away when they come up as enrollable off the waitlist. They are then deferred but remain on the waitlist until they are ready to enroll. This data will be monitored as a part of implementation.

## **DMS Restructuring Status**

- DMS has been reorganized under three functional area categories:
  - o Program Benefits and Service Delivery (all of long-term care, Medicaid benefits under acute and primary)
  - Systems Fiscal and Operations
  - o Eligibility and Enrollment

- Three programs are coming to the Bureau of Children's Services (BCS) effective September 22, 2020:
  - Care4Kids, a collaboration between DHS and the Department of Children and Families (DCF) to work holistically to meet medical and community needs of children in out of home care,
  - Children Come First and Wraparound Milwaukee, programs in Dane and Milwaukee counties that serve children with significant mental health needs, and
  - o Children with Medical Complexity (CMC).

# **CLTS Waiver Renewal Status Update**

• This initiative is conducting a large effort to collect stakeholder and family feedback.



CLTS Family Outreach Metrics.docx

- There were three family input sessions conducted in October (10/7, 10/8/, 10/9).
  - o 108 individuals attended across three sessions.
  - o Variety of perspectives were represented across regions and age groups of participants and affiliation to program.
  - o Themes from feedback included:
    - CLTS is helping families get care for their child.
    - Families need more support such as parent to parent support and emotional support, support for siblings.
    - Lack of providers.
    - Inconsistency across counties and across Support and Service Coordinators (SSCs).
    - Need for more information on what is available in the program and community services available.
    - More formalized safety and community planning for their child.
    - Increase food and nutritional supports.

- Family Input Next Steps
  - Presentation will be posted to the CLTS website and will be translated in Hmong and Spanish.
  - Conducting a survey to collect family feedback, over 125 responses so far, closes 10/16/20
- o Initiative next steps include: discussion about provider shortage, methods to elicit more providers in CLTS and racial equity as a priority, especially as BCS identifies waiver renewal changes.

## **CLTS Provider Directory**

- A statewide provider directory has been developed in three phases in response to a CMS corrective action plan; it is now online and available to CWAs and families.
- There are a variety of ways that one can search for providers on the directory (<a href="https://www.dhs.wisconsin.gov/clts/clts-provider-map.htm">https://www.dhs.wisconsin.gov/clts/clts-provider-map.htm</a>):
  - Locate a provider based on the countywide map
    - Clicking on each county will bring up a result of all providers registered to provide services in the county
  - Locate a provider by service
- DHS will continue to complete verification that all providers meet initial qualifications and licensing requirements.
- CWA will determine providers fully qualified, including verification that the provider has the training for the specific needs of the participant, conduct caregiver background checks.
- DMS Numbered Memo 2019-10 includes details and requirements for the provider directory and registry.
- A comment was shared recommending easier descriptions for the services available for families to understand as they view the directory and find providers (i.e. services at a glance page).

## COVID-19

- BCS has communicated a variety of operational guidance to CWAs during COVID-19, including:
  - Tracking enrollments and giving operational instructions to CWAs on COVID-19 allowances and provisions.
  - o Suspended annual functional screens during the pandemic.
  - Supports to CLTS during school services which instructs CLTS to apply flexibility with services to support families for remote school, not supplanting IDEA, and letting go of the concept of typical school hours.

- Three Key Questions that DHS has been monitoring
  - Has there been a significant change in the number of children receiving services?
    - Every month saw an increase from January-June
  - Has there been a significant change in the average amount of services each child receives?
    - There was not significant change January-May
    - June-August saw an increase in amount of services
  - Has there been a significant change in the types of services each child receives?
    - Overall, first five months of the year no major changes. Changes occurred beginning of June.
    - Increase in respite services beginning in April to August
      - Significant increase especially beginning in June likely related to respite summer camps
    - Support and service coordination decreased June to August
- o Discussion
  - Common trends despite the pandemic
    - It is common for respite services and other services to increase in the summer
    - Looking at the potential of acuity that can impact services

# **BCS Program and Access Initiative**

Status update and CLTS Council Role. The council reviewed the initiative work plan, which includes DHS action items that do
not need funding as well as areas that required DHS funding to implement.

There was also discussion about the council role and how to effectively provide input on the Access Initiative. Suggestions included: continue to keep the Access Initiative as an ongoing agenda item for each council meeting and creation of a sub-committee for the full council to contribute to the initiative.

- The phases of the access initiative include:
  - Transition from Compass Wisconsin: Threshold to county administration.
  - Katie Beckett will continue to be within DHS until some system issues are worked out before turning to CWAs for responsibility. Goal to move to CWAs by January 2022.

- DHS administers surveys each year to drive improvements.
- Summary of findings
  - o Opportunities of Improvement
    - Equipment and accommodations access

    - Transition planning
- Council feedback included:
  - o Starting conversations sooner for transition goals, such as 14 years old
  - Making sure families know their options
  - Continuity of services between CLTS and Family Care/IRIS
    - Each program operationalizes these services differently and how do we best support a seamless transition to account for this
  - o Schools should also be involved in these planning conversations
  - o Supporting County SSCs to coordinate with Aging and Disability Resource Center (ADRC) coordinators
