V. Discuss COVID Updates and Priorities for CPD Related to People with Physical Disabilities

- The Executive Committee discussed opportunities to join with other councils and committees to support and provide information, input and feedback
- Karen Secor provided an update on resources for Emergency Preparedness and resources related to COVID-19, and recommended that the Executive Committee members should discuss focus on more detailed information about pandemics.
 - A recommendation was made to expand the pandemic section based on the experiences from COVID-19, but not focused on COVID-19.
- Jason Ostrowski made a recommendation for the CPD Executive Committee to continue monitoring nursing homes and the changes necessary to ensure
 - Jason Ostrowski suggested that there might be opportunities for the CPD to collaborate with other councils and committees to address some of the concerns related to people with physical disabilities.

VI. Review and Discuss CPD Priorities in July 2020

• The Executive Committee discussed activities for the celebration of the American's with Disabilities Act (ADA) and not only celebrating, but also recognizing areas where there could still be improvement and raise awareness about disabilities.

- Jason Ostrowski recommended that topics could include accessible campus and university settings, but also bring awareness to employment, legislation changes, and possible collaborating with other councils or committees such as the Governor's Committee for People with Disabilities.
- ADA celebration suggestions were made including social media postings, communication or videos to raise awareness.
- Members are encouraged to send information to Jason Ostrowski for postings to the CPD Facebook page.
- Discussion was had on a request received by the Governor's Committee for People (GCPD)
 with Disabilities to provide input on the Medicaid Expansion policies released by the
 Governor's Task Force on Caregiving.
 - The GCPD reached out to other councils and committees to provide input on specific parts of the proposal and submit information to the GCPD which would be complied and submitted as public input.
 - Ben Barrett commented that there has been quite a bit of feedback from providers and professionals, but they are looking for input from consumer councils and individuals.
