# 6. Peer Values Reflection

DeAnna Cobun, Co-Chair reflected on the peer value of respecting all forms of diversity.

She emphasized the importance of authenticity, listening without judgment, and valuing differences. Then, she shared a personal story where she fell short of respecting all forms of diversity but learned to recognize that all trauma cannot be set aside by all people.

Members added reflections, including:

- Using meaningful activities to help clients navigate grief.
- Appreciation for the diversity present within CPSAC meetings.

DeAnna closed out with recognition that people experience and process trauma and healing in different ways, and that is ok.

#### 7. DHS 72 Presentation Discussion

Kenya Bright, Integrated Services Section Supervisor reported that DHS 72 will take effect on November 1, 2025 and proposed two options for the DHS 72 Presentation.

Members discussed whether to schedule a special meeting or wait until December for a full presentation.

#### **8. BPTR Peer Services Strategic Plan Presentation**

Kenya Bright presented on the Peer Collaborative Workgroup and its efforts to expand peer services.

#### Six priority areas were shared:

- 1. Training for non-peer roles in workplaces
- 2. Addressing peer workforce challenges in rural areas
- 3. Developing a Youth Peer Specialist curriculum
- 4. Supporting DHS 72 implementation
- 5. Educating supervisors of peers on ethics, boundaries, and supervision
- 6. Expanding peer services in the criminal justice system

## **Breakout Group Highlights**

- Group 1: Selected priorities #1 and #5. Emphasized that supervisor roles often default to clinical perspectives, and peer ethics differ from clinical ethics.
- Group 2: Selected priorities #3 and #5. Stressed the importance of youth peer specialists and consistent supervisor training across agencies.

• Group 3: Selected priorities #3, #6, and #2. Recommended separating justice system and recovery housing issues and highlighted the importance of supporting rural peer services.

- Group 4: Selected priorities #1, #4, and #5. Focused on training non-peers, supporting DHS 72 implementation, and clarifying supervision roles.
- Group 5 (main room): Selected priorities #1, #4, and #6. Suggested developing a core training that could also be adapted to address DHS 72 implementation and justice system expansion.

#### Consensus:

- Strongest support for Priority #1 (training for non-peer roles in workplaces).
- Additional interest in Priority #5 (supervision education) and Priority #4 (DHS 72 implementation)
- Members recommended forming a workgroup to advance these priorities in partnership with DHS and RITF.

#### 11. Subcommittee Reports

- <u>Governance Subcommittee</u> Charlie Hart Sheehan, Co-Chair reported that the bylaws are nearly complete. The draft will be distributed in advance and presented for approval at the December meeting.
- <u>Membership Subcommittee</u> Kimberlee Coronado, Co-Chair reported that membership applications from the spring have been reviewed. Orientation for new members will be held in October, with introductions scheduled for the December meeting. Six seats remain open, and recruitment materials and attendance letters have been developed.
- <u>Professional Development Subcommittee</u> Todd Campbell, Co-Chair reported that the group is researching strategies to address peer ethical concerns. Recommendations will be brought to the December meeting.
- <u>Employment Subcommittee</u> Tiffany Koch, Co-Chair reported that the group is continuing work on the Employer's Toolkit. A feedback workgroup has been formed, and a peer presentation was given by La Crosse Lighthouse. The subcommittee plans to nominate an additional co-chair in December.

## 12. DCTS Update - Joanette Robertson, Director of BPTR

#### **Resources and Updates:**

- SAMHSA released a Suicide Awareness Toolkit.
- DHS is relocating offices to 201 E. Washington.

#### **Funding:**

• Federal funding for block grants and the State Opioid Response Grant (approx. \$70M) remains delayed.

 Contracts will move forward, but partners cannot draw down funds until DHS receives Notice of Awards.

#### **Administrative Rules:**

- DHS 72 will be effective Nov. 1, 2025; Medicaid reimbursement for PRCs begins April 2026.
- Crisis Urgent Care and Observation Facilities emergency rule became effective June 16, 2025; \$10M in grants are expected.
- Crisis Hostels have been added as a short-term stabilization option (under 23 hours).
- DHS 75 revisions took effect Aug. 11, 2025; a public hearing is scheduled for Sept. 29, 2025.
- A new rule project is underway for psychiatric residential facilities for children.

- Community-specific trainings included participation from employers and agencies to strengthen connections for graduates.
