Encounter Datamart, 5010 Implementation

Summary

Starting in January 2012 all encounter submissions must be in the new 5010 format with some providers adopting 5010 before that after completion of a test submission. The **LTCare Encounter Datamart Universe** has updated with the new objects, tables and increased field lengths mandated by 5010 specifications. Only new submissions will have these additional fields and support to report on both submission versions is maintained. The root changes are to the source system and are all reflected in Encounter Datamart Universe.

Changes:

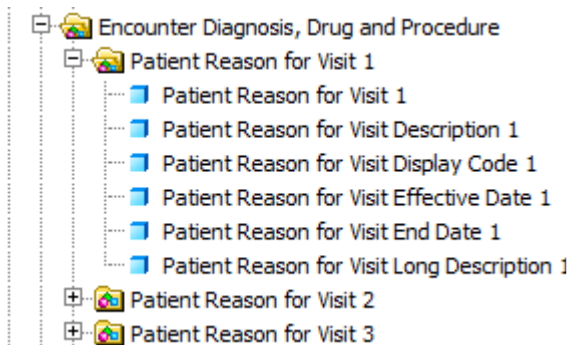
Length Increases

Name and other identifier lengths have been increased. Person names, provider names, DCNs and diagnosis codes are all increased in maximum size where they might have been cut off in previous submissions. The Universe objects are unchanged but the max data length accepted as part of a submission has been increased.

New Objects

New objects have been added although not all are required with a 5010 submission.

Patient Reason for Visit added. Up to 3 codes can be stored on each detail line.

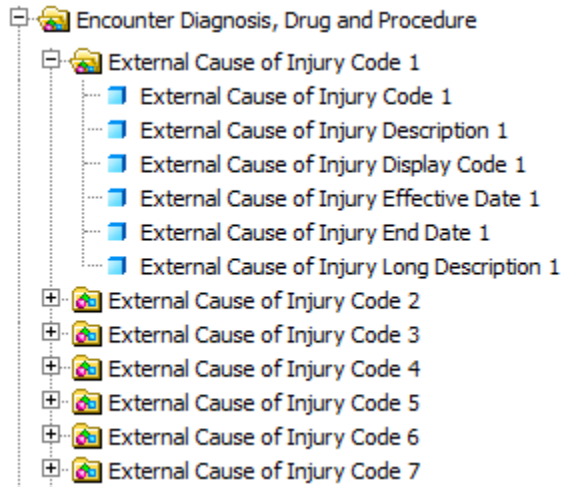


External Cause of Injury Codes expanded from 1 entry to 12 maximum (each entry is identical):

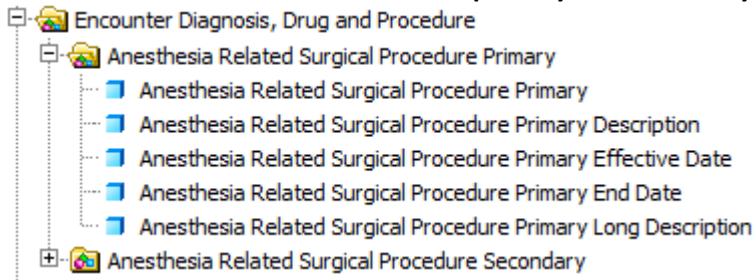

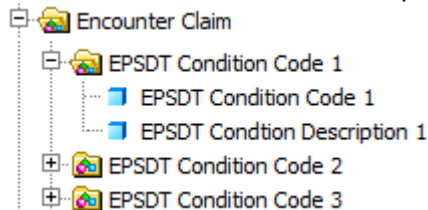

EPSDT Condition Codes added. Up to 3 can be stored on each detail line.



Additionally many new objects have been added to the main Encounter Detail Fact section:

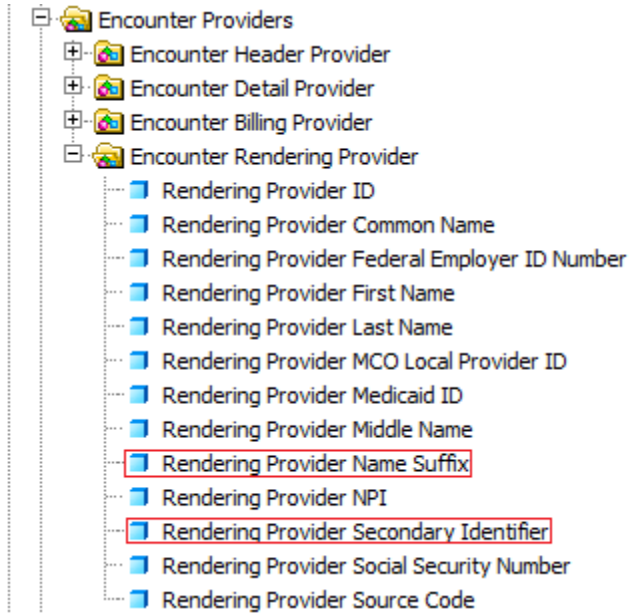

Providers also have new optional identifiers: Rendering Provider Secondary Identifier, Rendering Provider Name Suffix and Billing Provider Secondary Identifier.

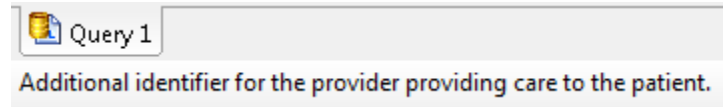
