# Release Notes 1.5.0.0

### Person Active/Archived Indicator

A modification was made to all functional screen data marts to allow data warehouse users to retrieve data by a functional screen status code. The change affects the adult, children, mental health, and personal care universes in the LTCare Data Warehouse.

The functional screen application allows the screener the ability to set an individual person as active or archived. The data received from the screen application which is loaded into the data warehouse contains the status indicator at the time the screen is loaded. If a screener changes the status code after a screen is loaded into the warehouse, the status code was not updated in the warehouse. The warehouse retained the screen status code that was present at the time the data was loaded. The data was found using the screen status code and screen status description objects in the Adult Screen Information.....Adult Screen Type Information folder.

A change was made to revise what is displayed in the warehouse. The screen status code and description objects were removed. Two new objects were created "Person Status Indicator" and "Person Status Description". The new objects are found in the Adult Screen Information.....Adult Screen Type Information folder. These new objects will display the status of an individual as of the last time the screen data was loaded into the data warehouse. The objects will only refresh once per month as the screen data loads into the warehouse.

Additionally, a new filter named Person Active Indicator was also added to the Adult Screen Filters folder. When used in a query, the Person Active Indicator filter will restrict screen results to only members that are active.

## **Assigned To Agency Added**

The functional screen application makes use of three agency types within the application. The agency types are as follows:

Eligibility Calculated Agency = This is the agency that actually pressed the "Calculate Eligibility" button.

Screening Agency = This is the agency that the screener is assigned to at the time the screen was created.

Assigned To Agency (NEW) = This is the agency that the screen is currently assigned to. For Example an ADRC may have calculated the eligibility and then transferred the screen to an MCO. The MCO is the assigned to agency.

The "Assigned To Agency" in the data warehouse will only refresh once per month as the screen data loads into the warehouse, and will reflect the currently assigned to agency.
