#### WAMS User ID

Active Flag, Certified Screener Flag, Old FSIA User ID, Previously Accessed Indicator, User Type, WAMS Login ID, and WAMS User ID represent new objects in Child Screener Information Folder.



**Active Flag** - Flag that specifies whether or not an account is active.

**Certified Screener Flag** - Indicates whether a specific user is a certified screener or not. Possible values are 'Y' or 'N'. Only screeners who are certified ('Y') will be able to work on a functional screen.

**Old FSIA User ID** - This user ID is what the user used to log into the old FSIA application when security was managed by CWA. The field is necessary for user validation when converting old users into the new system.

**Previously Accessed Indicator** - Indicates whether a user has logged into the FSIA application before or is this the first time (linking their new WAMS account to their old FSIA User ID).

**User Type** - The type of user.

WAMS Login ID - The WAMS Login ID.

WAMS User ID - The WAMS User ID.




