Wisconsin DHS Data Warehouse ICD-10 Update

Purpose/Background

The ICD-9-CM code set is being retired and replaced with ICD-10-CM and ICD-10-PCS. For services after Oct 1st 2015, ICD-9 codes will no longer be accepted on most claims and encounter submissions. Not every series of codes will be updated with a new code set.

Source systems should be updated to accept the new codes but not every system and code set will be updated. See below for reference:

Data Elements

ICD version indicator objects have been added to universes where a diagnosis or surgical procedure code is present. These objects display a simple '9' or '10' value indicating which version of the code is being used. All code objects with multiple versions will have this indicator added.

In addition, other universe objects have been updated to account for the recent ICD-10 updates such as the Diagnosis Display Code objects.

Reporting Impact

Reports with hard-coded ICD-9 code values will need to be updated to include ICD-10 codes or patterns needed. All existing codes and assignments will still be present and be valid for old records as well as new updates/reversals of records with dates prior to the October 1, 2015 cut-over. Users need to be aware that their reports will potentially need modifications.

In the LTCare Adult Personal Care Functional Screen Data Mart, the three ICD Diagnosis Codes now use
