Changes to Division of Care and Treatment Services Management Team

This memo announces changes to the Division of Care and Treatment Services (DCTS) management team as a result of the creation of new positions and a retirement.

Bureau of Prevention Treatment and Recovery

There are two new management positions in the Bureau of Prevention Treatment and Recovery. These positions are part of a reorganization to support the bureau's complex and growing workload.

Teresa Steinmetz assumes the role of deputy director. She is responsible for the day-to-day operations of the bureau, including program oversight and monitoring. She directly manages the supervisors in the bureau and office support staff. She reports to Joyce Allen, the director of the bureau. Steinmetz promotes to this position from the position of section chief for the bureau's Children Youth and Families Section.

Ryan Stachoviak assumes the role of section chief for the newly created Performance Management Section. This section works on program evaluation, data management, contracts management, and planning. Stachoviak promotes to this position from the position of the bureau's Community Mental Health Services Block Grant planner, disaster coordinator, and lead staff for the Wisconsin Council on Mental Health.

There are now five sections in the bureau: children youth and families (vacant, section chief), integrated services (Kenya Bright, section chief), mental health services (Joanette Robertson, section chief), performance management, and substance abuse services (Scott Stokes, section chief). Staff with similar duties are now grouped together. There are no changes to contact information for staff.

Winnebago Mental Health Institute

Tim Lundquist assumes the role of interim director of Winnebago Mental Health Institute. He fills the position vacated by Byran Bartow. Bartow has retired. Lundquist will serve until a new director is hired. He rejoins DCTS after retiring in March as director of the Wisconsin Resource Center.

The recruitment and selection process is underway for two other DCTS management team members: assistant division administrator and Northern Wisconsin Center deputy director. An announcement on these hires will be made in the coming weeks.
