

FS ABAWD & FSET Tool Statuses

FS Clock System Status

Active in FSET	Individual is participating in FSET for the current month and is expected to meet the ABAWD work requirement by the end of the month. This is only set if the individual is in their 3 rd TLB month, 3 rd Additional Month, or Extended Benefit Month.
Additional Month	Individual has exhausted all TLB months and has been granted three consecutive months of additional benefits due to meeting the ABAWD work requirement.
Exempt	Individual verified an exemption and is not required to meet the ABAWD work requirement for the month.
Extended Benefit Month	Individual has used three TLB months and three Additional Months, has participated in FSET in the 2 nd and 3 rd Additional Month, and is expected to participate in FSET the month this status is applied.
Ineligible	Individual is ineligible for FoodShare benefits in Wisconsin.
Met FSET Requirement	Individual met the ABAWD work requirement for the month by participating in the FSET program.
Met Work Requirement	Individual met the ABAWD work requirement for the month by working and/or participating in a work program.
Partial Month FS Issued	Individual received a partial month of FS benefits after the clock started. This is not a countable month.
Time-Limited Benefit	Individual received a full month of FS benefits as a Non-Exempt ABAWD and did not meet the ABAWD work requirement.
To Be Determined	Temporary status for an individual in a potential TLB or in an Additional Month. This will update after the Adverse Action batch run.

Exempt ABAWD	Individual has a verified exemption and is not required to meet the ABAWD work requirement but may volunteer for FSET.
Non-ABAWD	Individual is not an ABAWD and is not required to meet the ABAWD work requirement but may volunteer for FSET.
Non-Exempt ABAWD	Individual is an ABAWD and is required to meet the ABAWD work requirement in order to maintain FS eligibility.

FSET Tool Participation Statuses

Exempt ABAWD	Individual has a verified exemption and has chosen to volunteer in the FSET program.
Non-ABAWD	Individual is not an ABAWD and has chosen to volunteer in the FSET program.
Non-Exempt ABAWD	Individual is an ABAWD and is required to meet the ABAWD work requirement in order to maintain FS eligibility.
FS Ineligible	Individual is not eligible for FoodShare benefits.

FSET Tool Enrollment Statuses

Enrolled	Individual is currently enrolled in the FSET program.
Disenrolled	Individual is currently disenrolled from the FSET program.
Referred	Individual has been referred to an FSET agency but is not currently enrolled.
Withdrawn	Individual's referral has been withdrawn.
