Your ForwardHealth Card

If you do not already have a ForwardHealth card, you will get one in the mail within 3-5 business days. If you have a ForwardHealth card from past coverage, a new one will not be mailed. If you need medical services before you get your ForwardHealth Card, you can bring the temporary card below when you visit your medical provider or pharmacy. Keep in mind that you will not get a temporary card unless you are enrolled in BadgerCare Plus or Family Planning Only Services this month and/or next month.

If you no longer have a ForwardHealth card, you must ask for a new one. You can get a new ForwardHealth Card using your MyACCESS account at ACCESS.wi.gov, or by calling Member Services at 1-800-362-3002.
