**Spousal Impoverishment Income Allowance Federal Poverty Level Adjustment**

**EFFECTIVE DATE**

July 1, 2018

**PURPOSE**

This Operations Memo provides local agencies with the 2018 amounts for the spousal impoverishment community spouse income allowance, the spousal impoverishment family member income allowance, and the shelter base amount.

**BACKGROUND**

The U.S. Department of Health and Human Services published its annual update of the Poverty Income Guidelines, also called the federal poverty level (FPL) guidelines, in the Federal Register on January 18, 2018. These guidelines are available at the following website: <https://aspe.hhs.gov/poverty-guidelines>.

Income limits and other amounts used in eligibility determinations for some categories of Medicaid are based on the FPL. Federal and state law mandates that the income limit changes related to spousal impoverishment have a delay in their effective dates. As a result, the changes are effective July 1, 2018.

**POLICY**

The spousal impoverishment community spouse income allowance allocation, the spousal impoverishment family member income allowance, and the shelter base amount will increase effective July 1, 2018.
