YoungStar Adjustment Information

If your program is rated 4 Stars or 5 Stars, a YoungStar adjustment will be made directly to you to support quality services within the child care setting. For providers located outside of Wisconsin, the subsidy amounts are issued to parents at the 3 Star level and are eligible for a 10% increase based on accepted accreditations. Provider Responsibilities, Overpayments and Sanctions

- By accepting children with Wisconsin Shares Child Care authorizations and subsidy amounts, you agree that you are currently adhering to and will continue to adhere to all of the Wisconsin Shares Child Care program requirements, policies and the following provisions:
 - You are certified, licensed, or are operated by a Wisconsin public school board, and you are complying with all of the requirements for your regulation.
 - Unless you are an out-of-state provider or an in-home provider, you are participating in the YoungStar quality rating and improvement system and you are fulfilling the YoungStar contract requirements. If you are an out-of-state provider or you provide care in the child's home, you have signed a Wisconsin Shares Child Care contract and you are fulfilling the Wisconsin Shares Child Care contract requirements.
 - You agree to notify the local child care agency when you know that a child will no longer be attending your child care center/home.
 - You agree to notify the local child care agency when a child has not attended within the previous 30 days.
 - You agree to care for no more than the number of children that your regulations allow, including private pay and subsidized children.
 - You agree to care for children only within regulated hours and not for more hours in a day than permitted.
 - You agree to provide child care at the authorized location and will not take the child to another child care center to provide care.
 - You agree to report errors or violations of the Wisconsin Shares Child Care program that you or your child care program may have committed, suspected program violations by parents, or suspected program violations by other child care providers to the DCF Fraud Mailbox at dcfmbchildcarefraud@wisconsin.gov or by calling 1-877-302-3728.
- Failure to follow these provisions may result in the recoupment of overpayments, refusal to allow children with new child care subsidy authorizations to attend your child care program, and/or the termination of current child care subsidy authorizations to your child care program.
- Intentional program violations may result in the recoupment of overpayments, additional penalties, and/or being permanently suspended from the Wisconsin Shares Child Care program.
