**PURPOSE**

This memo provides notice of supplemental Income Maintenance (IM) Program funding for CY 2016 for IM Consortia and Tribal agencies. The funding in this memo is to address workload associated with FoodShare Able-Bodied Adults without Dependents (ABAWDs) requirements.

**BACKGROUND**

Funding totaling \$4,730,100 for CY 2016 was budgeted for IM Consortia and Tribal agencies to support the expected workload increase due to the implementation of the FoodShare ABAWD requirements.

**ABAWD SUPPLEMENT ALLOCATION**

The CY 2016 FoodShare ABAWD supplement for the Consortia totals \$4,673,000 and has been allocated to each Consortium using the caseload count of all open, closed and pending cases for the period from December 2014 to May 2015.

The CY 2016 FoodShare ABAWD supplement for the Tribal agencies totals \$57,100 and has been allocated to each Tribal agency using the caseload count of all open, closed and pending IM cases for the period from December 2014 to May 2015.

**DISTRIBUTION METHODOLOGY**

The allocations shown in Attachment I are for CY 2016, based on the methodologies described above, and the funding identified for CY 2016.
