PURPOSE

The purpose of this Administrator's Memo is to announce funding to support workload related to implementation of the Affordable Care Act (ACA) for the period of January 1, 2016 through December 31, 2016.

BACKGROUND

The ACA supplemental funds are provided to address workload impacts on the income maintenance consortia as a result of the ACA.

AMOUNT AND USE OF FUNDS

The amount of the ACA supplement allocated to the Consortia and Tribal agencies is \$4,907,400 All Funds (GPR and FED). Funds will be distributed through a separate ACA Contract for the period of January 1, 2016 through December 31, 2016.

DISTRIBUTION METHODOLOGY

The CY 2016 total for the Consortia is \$4,772,600 allocated using the six (6) month average (December 2014 through May 2015) caseload of all open, pending, and closed IM cases.

The CY 2016 total for the tribes is \$134,800 allocated using the six (6) month average (December 2014 through May 2015) caseload, of all open, pending and closed IM cases.
