**PURPOSE**

The purpose of this Administrator's Memo is to announce funding to support workload related to implementation of the Affordable Care Act (ACA) for the period of January 1, 2017 through December 31, 2017.

**BACKGROUND**

The ACA supplemental funds are provided to address workload impacts on Income Maintenance (IM) agencies as a result of the ACA.

**AMOUNT AND USE OF FUNDS**

The amount of the ACA supplement allocated to the Income Maintenance Administrative Allocation (IMAA) agencies is \$2,453,702 (all funds) (see Attachment I). Funds will be distributed through a separate ACA contract for the period of January 1, 2017 through December 31, 2017.

**DISTRIBUTION METHODOLOGY**

The CY/FFY 17 ACA funding budget totaling \$2.45 million is 50% of the amount that was budgeted for CY/FFY 16. Consortia requested that the ACA funding reduction for CY/FFY 2017 be evenly applied across consortium IM funding. Therefore, a funding reduction limitation of (-) 6.719% was applied to each consortium's CY 2016 combined base/ACA/ABAWD funding amounts to evenly distribute the ACA funding reduction for 2017.

Tribal ACA allocation for FFY 17 is at the FFY 16 funding level less a 50% reduction.
