Wisconsin Shares Child Care

EFFECTIVE DATE: September 1, 2018

PURPOSE: The purpose of this Operations Memo is to introduce the new income limit for parents who are receiving Wisconsin Shares Child Care.

BACKGROUND: Currently, to be financially eligible for Wisconsin Shares Child Care Subsidy, a family's income must be at or below 185% Federal Poverty Level (FPL) at application. In order to maintain ongoing eligibility for Wisconsin Shares, the family's income must not exceed 200% FPL. With the enactment of 2017 Wisconsin Act 59, a family's income must still be at or below 185% FPL at application, but the family may continue to be financially eligible for Wisconsin Shares until their income exceeds 85% of the Wisconsin State Median Income (SMI) for their family size.

POLICY: The following policy will be added to the Wisconsin Shares Child Care Policy and Process Handbook with the next release. The Section number for Maximum Gross Income for Ongoing Cases will be changing from 1.5.1.2 to 1.4.1.2 with the next release.

1.4.1.2 Maximum Gross Income for Ongoing Cases

The maximum gross income threshold is 85% of the State Median Income (SMI) for each Assistance Group (AG).

These figures were effective September 1, 2018. 85% SMI and the corresponding Federal Poverty Level (FPL) are updated annually.

CWW CHANGES: Changes will be made to CWW to support the new program limit on September 8, 2018. Workers running eligibility on Monday, September 10, will see the new FPL percentage (equivalent to 85% SMI) display for ongoing cases on the Child Care Budget page in CWW. The new FPL will be dynamic based on Assistance Group size, as demonstrated in the table above.
