## **PURPOSE**

This operations memo announces an eligibility change for health care members and FoodShare members receiving Residential Substance Use Disorder (RSUD) treatment beginning February 1, 2021.

## **BACKGROUND**

The 2015–2017 Biennial Budget authorized Wisconsin Department of Health Services (DHS) to include residential treatment for substance use disorder as a Medicaid- and BadgerCare Plus-covered service

On October 31, 2018, CMS approved an amendment to Wisconsin's BadgerCare Reform Section 1115 Demonstration waiver that authorizes federal funding for RSUD treatment provided to members enrolled in full-benefit Medicaid and BadgerCare Plus programs. The waiver allows DHS to offer RSUD treatment to full-benefit health care members through all state-certified residential programs regardless of size, including institutions for mental disease (IMDs). As a result, full-benefit health care members will have access to RSUD treatment services and will maintain BadgerCare Plus or Medicaid eligibility while receiving these services if they continue to meet all other program rules.

## **POLICY**

## **HEALTH CARE**

Effective February 1, 2021, coverage for RSUD treatment under full-benefit Medicaid and BadgerCare Plus plans will be available to members of all ages. To support this new service, the following will apply:

- Health care members receiving RSUD treatment are considered temporarily absent from the home while in treatment, as long as the member intends to return to the home following the treatment.
- Members will maintain their eligibility for BadgerCare Plus or Medicaid while residing in a certified
  treatment facility for purposes of RSUD treatment as long as they continue to meet all other program
  rules. This means that an individual of any age who is receiving RSUD treatment while residing in
  an IMD is eligible for BadgerCare Plus or Medicaid as long as they continue to meet all other
  program rules.
- A health care member residing in a medical institution solely for the purpose of receiving RSUD treatment is not considered an institutionalized person and therefore is not subject to patient liability, divestment rules, and spousal impoverishment rules.
- The cost of RSUD treatment is subject to estate recovery only if one of the following is true:
  - The member is age 55 or older and participating in a home and community-based waivers program when receiving RSUD treatment; or
  - The member is participating in Institutional Medicaid and residing in a nursing home or hospital when receiving RSUD treatment.

# **FOODSHARE**

A FoodShare member receiving RSUD treatment is considered temporarily absent from the home while in treatment as long as the member plans to return to the home following treatment.

# CARETAKER SUPPLEMENT, WISCONSIN SHARES CHILD CARE AND WISCONSIN WORKS

There are no changes to Caretaker Supplement (CTS), Wisconsin Shares Child Care or Wisconsin Works (W-2) policy.

Individuals residing out of the home and receiving RSUD treatment are not eligible for CTS or Wisconsin Shares Child Care.

W-2 participants who are receiving RSUD treatment may remain eligible for W-2 if they are able to participate in activities and retain care and control of their children.
