**PURPOSE:** This Operations Memo informs local agencies of updates to the Wisconsin Shares Handbook FSET crosswalk in Section 5.1.5.

**BACKGROUND:** Wisconsin Shares Handbook Section 5.1.5 includes a crosswalk that describes which of the FSET activity codes qualify as an approved activity for Wisconsin Shares. The crosswalk is being updated to align with activity code changes made by FSET.
