<u>Review and approval of March 14, 2025 minutes:</u> Charline Hart Sheehan motioned to approve the minutes. Christopher Zahn seconded the motion. Minutes were approved on unanimously.

Peer Values: David Stanley shared on the peer value of self-determination.

- Self-determination is one of the core peer values. It is the right to make one's own decisions and have
 freedom from coercion or having someone else making decisions for them. Peer specialists support the
 facilitation and creation of an environment where people can feel free to tap into their inner motivation.
 Peer support specialists don't fix or save, we create space for one to tap into resilience and their inner
 wisdom.
- David shared an example of self-determination in action which included the peer participant an opportunity to participate in decision making concerning his recovery without the peer specialist enforcing rules. Self-determination is asking, "what steps or actions do you want or are you able to do right now? Are you truly ready for this change?"

Peer Presentation: Katie Sparks, Crisis Services Peer Coordinator, DHS presents the 2023 DHS Peer Crisis Work Survey Results and Insights. The survey was released in October of 2023. Please see the attached PowerPoint presentation and the full report can be accessed here: Peers in Crisis Services: Results of a 2023 State Survey.

<u>Peer Voice – Peer Survey Questions:</u> Tanya Kraege facilitates a conversation surrounding the following questions:

- What, if any, do you think were the most valuable pieces of the survey?
 - o People did not think they had the money for certification.
 - o The living wage reflects the value of peer services.
 - o All of it is valuable, it can be used publicly for educational and funding purposes.
 - o Trainings to promote the understanding of the values of peer support for multidisciplinary teams.
- What changes would you suggest to future surveys, if any?
 - o For those interested in working with involuntary hospitalizations, ask what is the motivation to work in involuntary hospitalizations as a peer, it could be a moral injury and not necessarily align with peer values. Yet, a lot of the "other" responses in the survey were peers who wanted to work in that environment to provide the peer perspective or advocate for less intensive treatment options. Understanding the why would help create more clarity for peer responsibilities in crisis services.
 - What do peers need most from their employers is more continuing education and asking more specifically regarding what kind of continuing education or topics are peers seeking to be successful in providing services?
 - o It may be helpful to disseminate the survey during recertification time to capture more peers to complete the survey.

o Produce an employer-based survey – ask questions like what do the benefits look like? For example, do they offer PTO, medical benefits and what pay do they provide? Is there funding allocated to pay for the certification/recertification or professional development of a peer specialist? Or how do they advance peer specialists within their organization?

- Take those with technology barriers into consideration when disseminating a future survey to get a good subset of our diverse experiences.
- What audiences do you think could benefit from current and future development and results?
 - o Funders, healthcare providers and team members of peer providers so they can understand how to value peer specialists and county supervisors.
- Was there any language you would consider changing and why?
 - This survey speaks volumes to how DHS values how the peer support work is done, how to retain the workforce, the challenges the workforce is experiencing, and receiving feedback.

Public comment (limited to three minutes per person):

- Brian Kozala introduced himself He works with Rock County in the CCS Department and wants to get more involved with statewide peer work.
- Frank Zufall a reporter for the Wisconsin Examiner wrote an article focused on peer support in the Department of Corrections and the Department of Community Corrections. He is interested in doing a part 2 and is interested in interviewing peer support specialists to advocate and bring awareness to peer services throughout Wisconsin because there are many people in the community do not know what peer specialists do.

• Federal Budget updates: In order to avoid a federal budget shut down, congress must act to provide more funding either through another short term extension or a bill that lasts through the end of the federal fiscal year in September. The federal fiscal year is October 1 – September 30, 2025. The House passed a full year continuing resolution to finalize the fiscal year 2025 appropriations (click here for more information). It is now in the Senate, where the outcome is uncertain because it needs a bipartisan support for it to pass – this means 60 Senators. If there is a shut down, the impacts on Wisconsin will depend on how long it lasts. Then, the following ForwardHealth message was shared (To sign up for ForwardHealth updates, click here):

"The Wisconsin Department of Health Services (DHS) is closely monitoring all of the activities occurring at the federal level, including the possibility of a government shutdown. Our goal is to keep our partners, providers, and public informed, especially our Medicaid, FoodShare, and WIC members who receive benefits and services.

- o If the United States Congress does not pass a spending bill before midnight on Friday, March 14, there will be a government shutdown. If there is a shutdown:
- Members of BadgerCare Plus and Wisconsin Medicaid programs will still have coverage to get the care and services they need.
- Members of FoodShare are currently receiving their March benefits on their QUEST cards on the normal schedule. They can use any benefits that are on their card to buy food during a shutdown.
- WIC participants can continue to use their benefits and WIC vendors will continue to accept WIC benefits."

If there is a government shut down and it affects programs DHS has, we will communicate with our partners accordingly.
