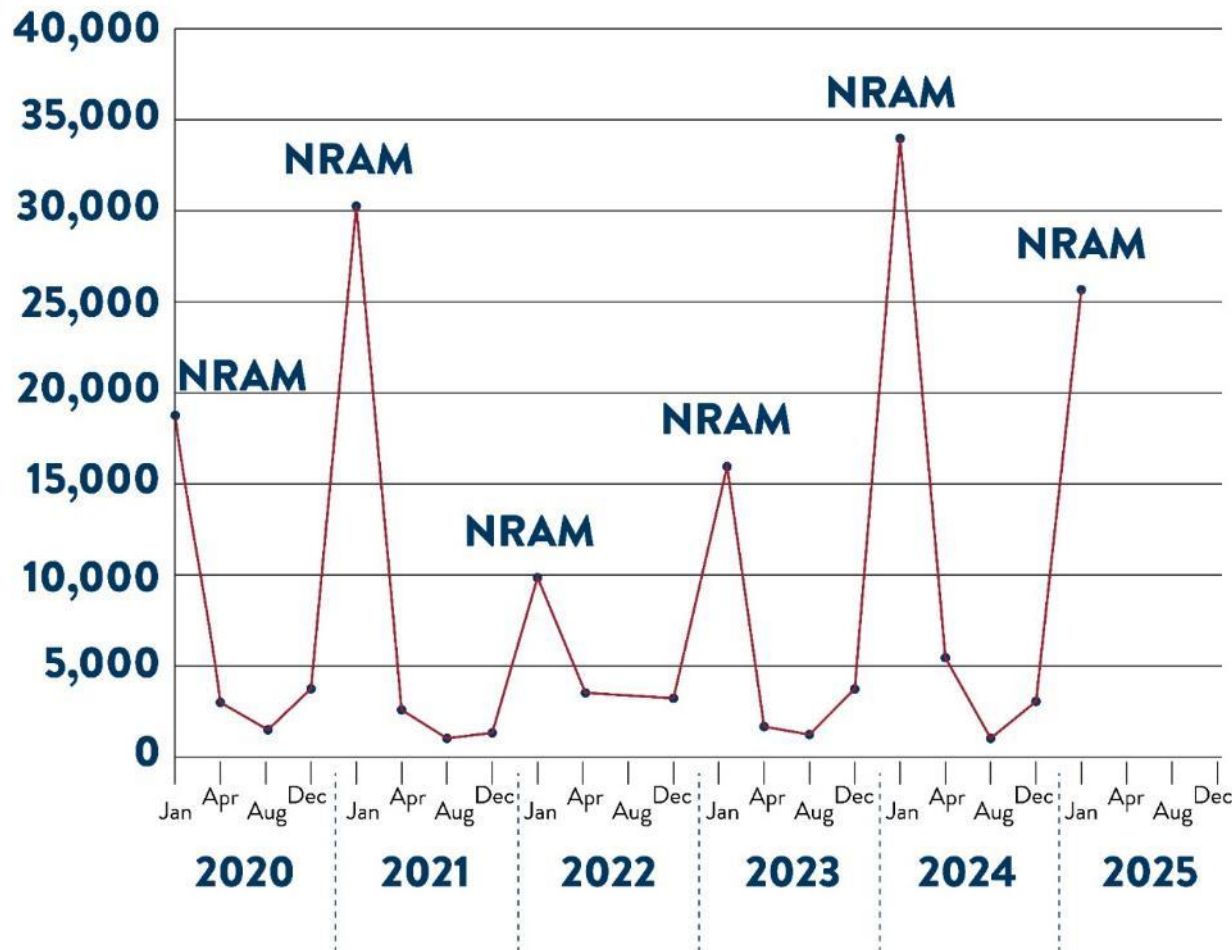

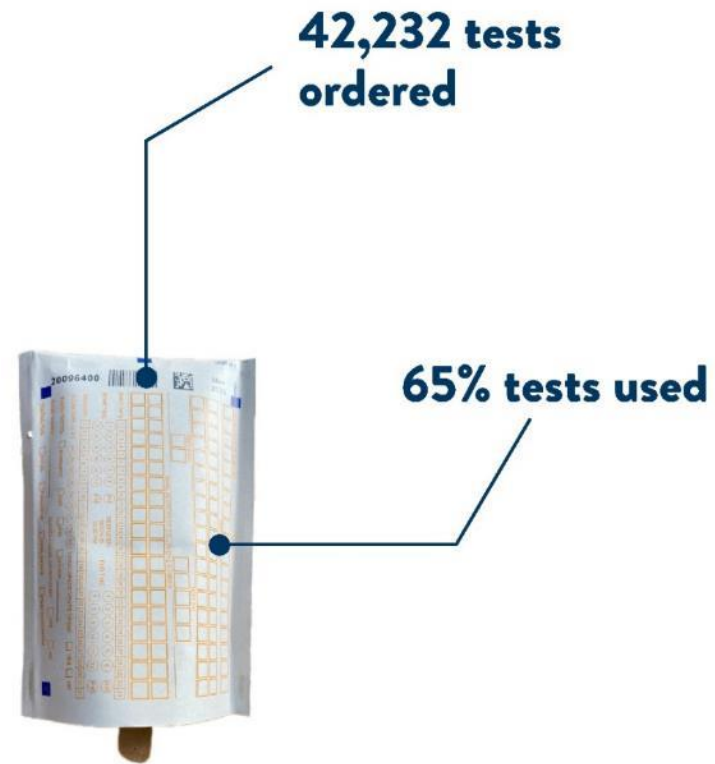
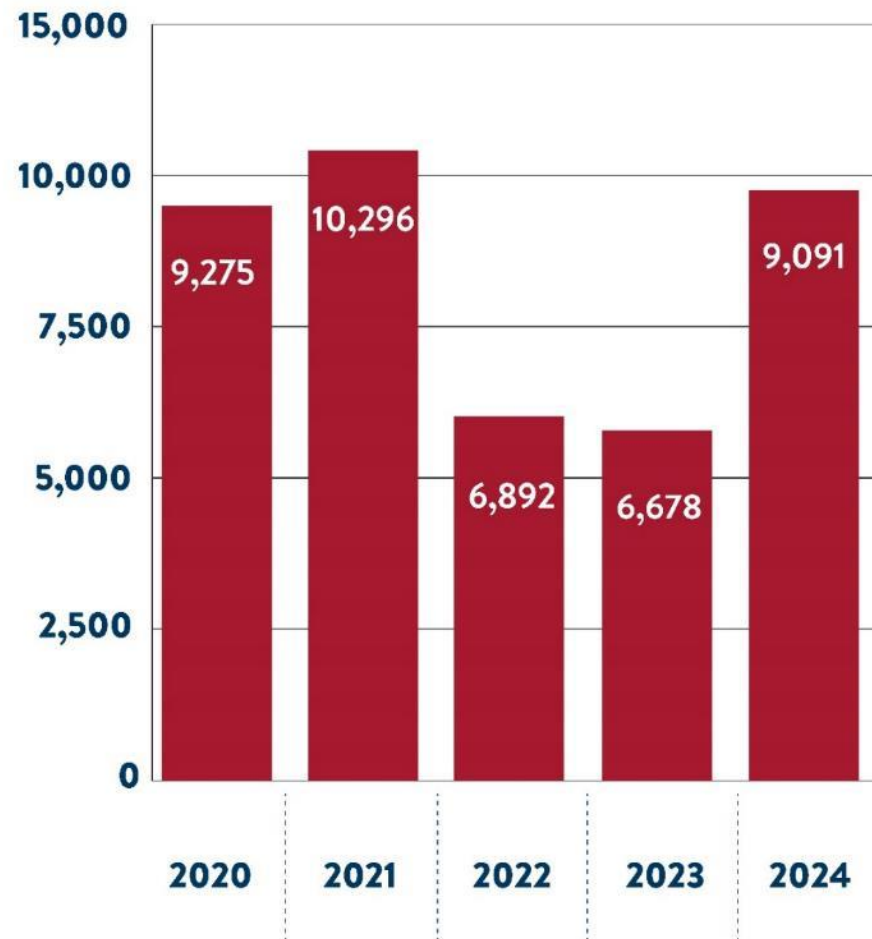


Trends & Fun Facts

(2020 - 2024)**





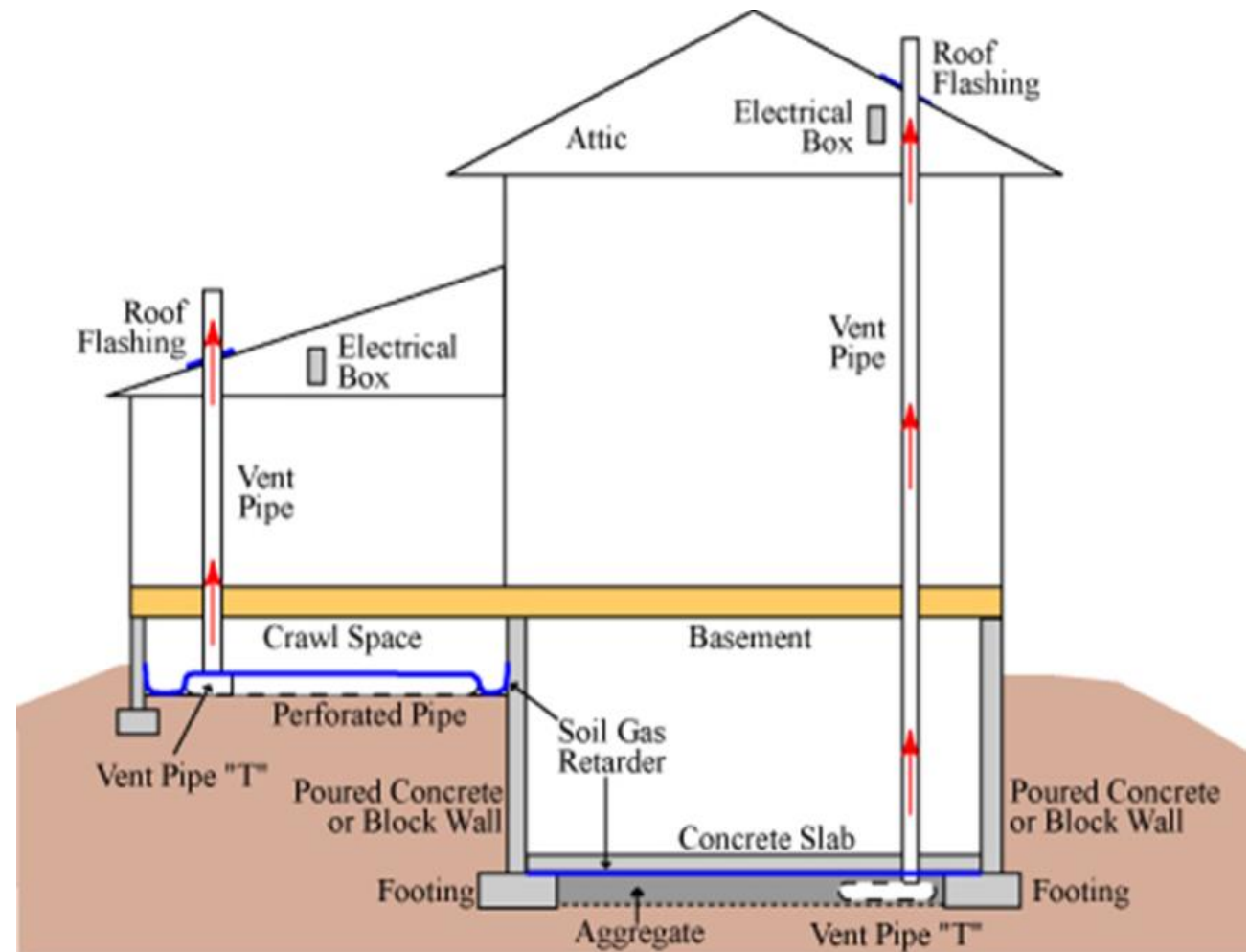
Existing Laws and New Policy Efforts

Existing Law: New Homes Must be Built “Radon Resistant”

- Passive required in code since 2009
 - No fan
 - ~40% reduction
 - 21,207 housing units built (10/1/24-9/30/25)
- Active (recommended)
 - Radon fan
 - ~90+% reduction
- DLI is revising building code including changes to radon



Radon in Home Sales – MN Radon Awareness Act

- No testing or mitigation required
- Testing and mitigation can be done (eg, during home inspection)
 - Use licensed pros
- Data pros reported to MDH (2024-2025)
 - ~19,000 homes tested in real estate
 - Out of the ~25,000 total housing units tested by pros



Existing Law: Disclosure and Notification Required in Home Sales

Effective January 1, 2014 seller must

- Disclose:
 - Tested?
 - Result
 - Mitigation?
 - Records
- Provide:
 - a radon warning statement
 - “Radon in Real Estate Transaction” publication



Existing Law: Professional Radon Licensing

- License required in Minnesota for radon work
 - If you don't own or lease the property
 - Professionals testing for radon (home inspectors, consultants, etc.)
 - Professionals mitigating radon (plumbers, HVAC contractors, etc.)
 - Mitigation Companies
 - Laboratories

Numbers of Credentials 2025

- 116 mitigators
- 382 measurement pros
- 13 labs
- ~8,000 tags (radon systems)



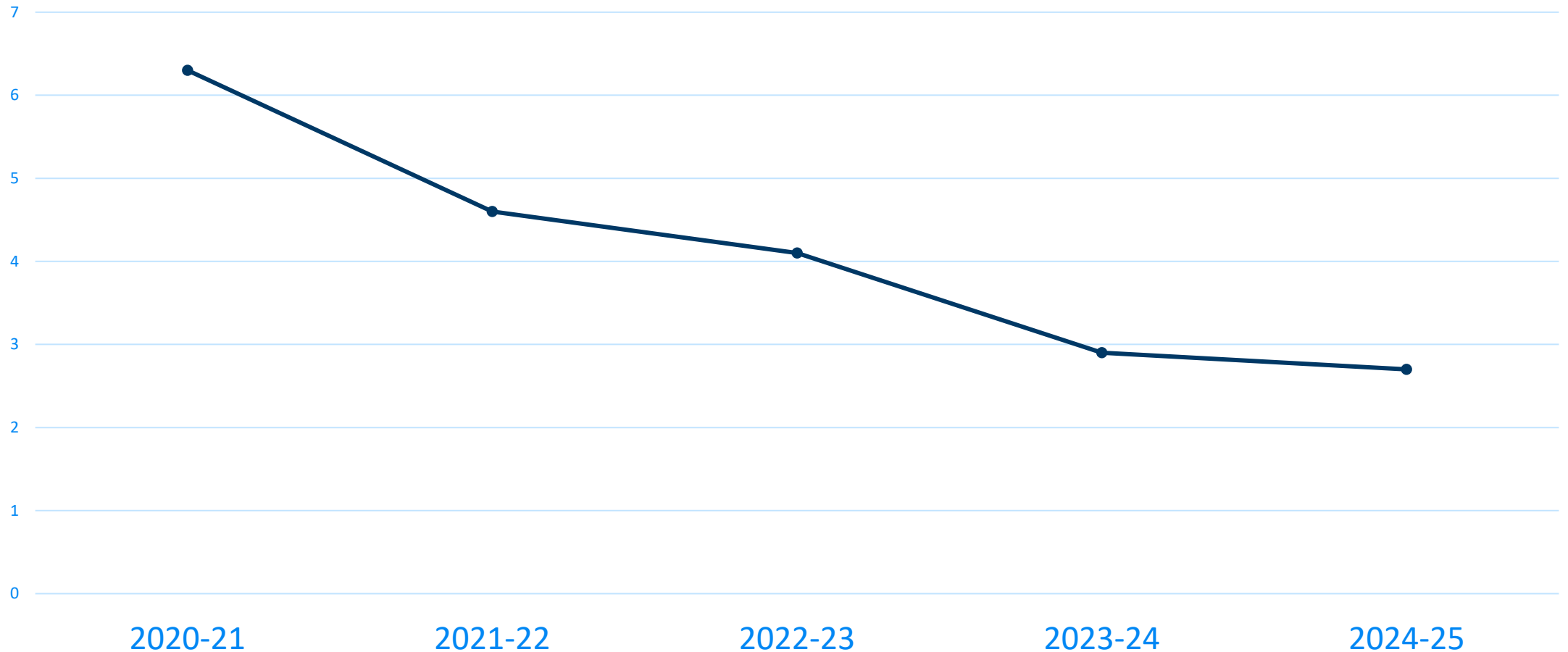
Our Licensure Activities

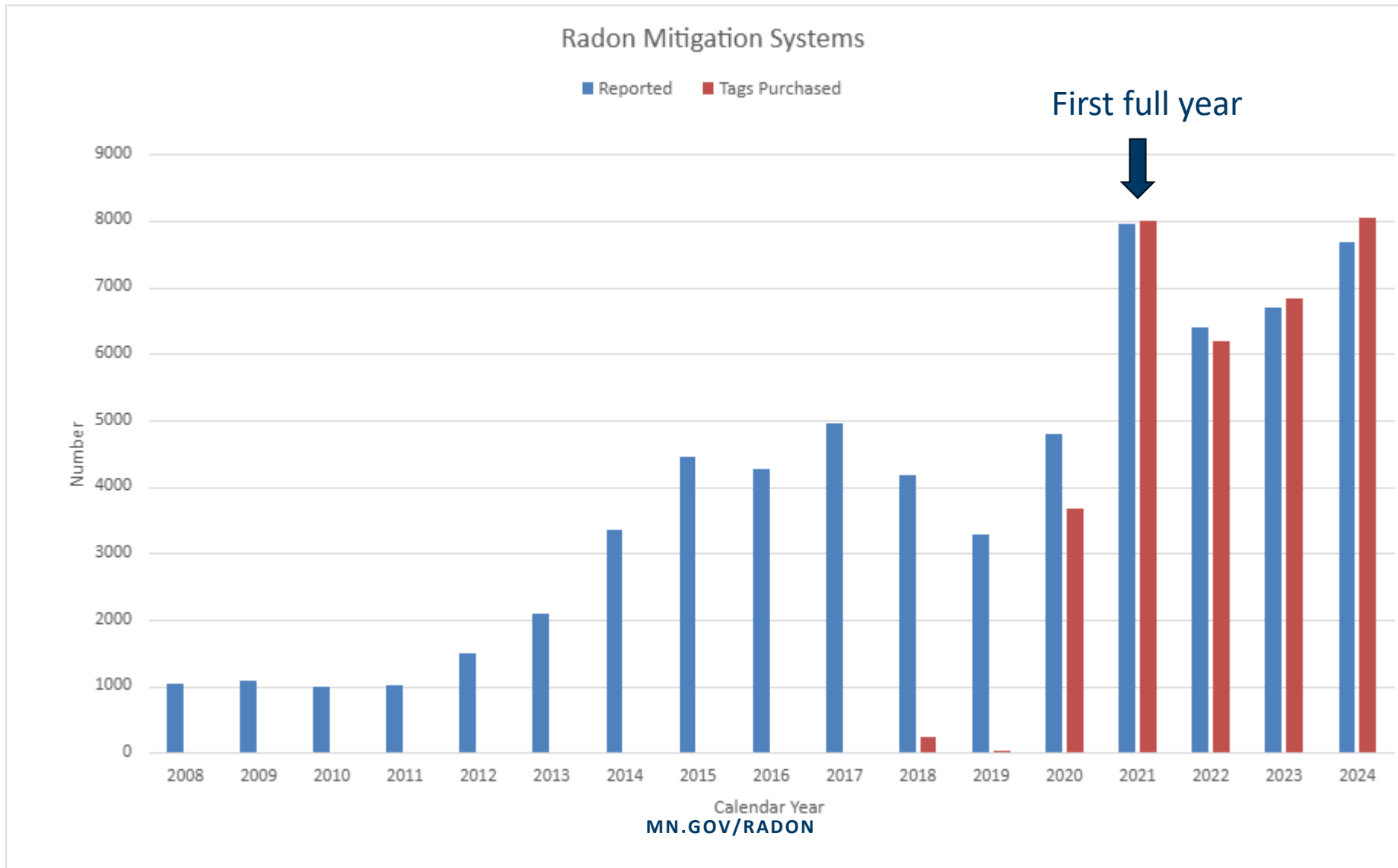
1. License reviews (450 applications)

MN Radon Licensure

- Is contractor licensed to test or mitigate?
 - check MDH site
 - ask for proof of current MDH license
 - not same as certification
- Radon pros can do both mitigation and measurement (if licensed for both)
- Homeowners can request a free mitigation inspection of recent installation (contact us)
