## 2026

### Retired data elements

- Unplanned visit to the operating room

### New data elements

- Unplanned return to the operating room
- Timely arrival for consulting services
- FAST exam
- Registrar name
- Reason SBIRT not performed

### Other Changes

- Pre-hospital procedures updated to remove non-procedures from options list.
- Medications updated to remove non-medications from options list.
- Referring hospital medications updated to remove non-medications from options list.
- Pediatric option added to consulting service type.
- ED discharge time name changed to ED physical discharge time to distinguish from similar data element.
- ED discharge date name changed to ED physical discharge date to distinguish from similar data element.

- Reason for transfer delay has additional options added and some options removed to have more concise list of options.
- PI audit has added additional options and some options removed to have more concise list of options.
- Data element labels in Report Writer have been updated for consistency across all types of reports.

## 2025

### Retired data elements

- Sex
- AIS 05, Update 08
- Gender identity

### New data elements

- Sex assigned at birth
- Gender
- Gender-affirming hormone therapy
- Intubation prior to arrival
- Intubation location
- Primary medical event
- Autism spectrum disorder
- Bronchopulmonary dysplasia/chronic lung disease
- Ventilator dependence

### Other Changes

- Patients transferred or discharged to hospice added to inclusion criteria.
- Initial assessment vitals date and time required by state direct entry.
- Emergency medicine option added to attending MD/staff service.
- Consultation option added to trauma team activation.
- Screening, brief intervention, and referral to treatment (SBIRT) data element series added as optional.

## 2024

### Retired data elements

### New data elements

No new data elements.

### Other Changes

- Hospital admission date and time changed from optional to required by state direct entry.

- Referring facility changed from required by direct entry only to required for all users.
- Mode of arrival changed from required by direct entry only to required for all users.
- ED discharge date and time changed from required by direct entry only to required for all users.
- Hospital discharge date and time changed from required by direct entry only to required for all users.
- Referring facility arrival date and time changed from required for direct entry only to optional.
- Referring hospital discharge date and time changed from required for direct entry only to optional.
- Extrication changed from required for direct entry only to optional.
- EMS service name changed from required for direct entry only to optional.
- EMS run sheet/status changed from required for direct entry only to optional.
- New activation level changed from required for direct entry only to optional.
- Safety equipment devices added as optional.
- Optional data elements added to data dictionary.

## 2023

### Retired data elements

- Angina pectoris
- Mental/personality disorders

### New data elements

- Bipolar I/II disorder
- Major depressive disorder
- Other mental/personality disorders
- Post-traumatic stress disorders
- Schizoaffective disorders
- Schizophrenia
- Primary trauma service type

### Other Changes

- Supplemental cause of injury added as optional.
- First antibiotic administration time and date added as optional.
- Notes added as optional.

## 2022

### Retired data elements

- Extremity compartment syndrome
- Pre-hospital cardiac arrest

### New data elements

- Gender identity

## Other Changes

- Exclude in-house traumas from inclusion criteria.
- Include patients evaluated in the ED after a traumatic event where an included injury is treated in ED, but patient is admitted for work up of a medical condition.
- Include patients transferred from one acute care hospital to another acute transfer hospital by any means of transport, not only via EMS.

## 2021

### Retired data elements

No retired data elements.

### New data elements

- Highest activation
- Trauma surgeon arrival date and time
- EMS patient care report unique identifier (UUID)

## Other Changes

- Exclude burn injuries from inclusion criteria.

## 2020

### Retired data elements

- Report of physical abuse
- Investigation of physical abuse
- Caregiver at discharge
- Signs of life
- AIS predot code
- AIS severity
- Unplanned return to the operating room

### New data elements

- Pregnancy
- AIS code
- Delirium
- Unplanned visit to the operating room

## Other Changes

- Trauma center criteria changed to trauma triage criteria (Steps 1 and 2.)
- Vehicular, pedestrian, other risk injury changed to trauma triage criteria (Steps 3 and 4.)

# 2019

## Retired data elements

- Co-morbid conditions

## New data elements

- Initial field GCS – Total
- Initial field GCS 40 – Eye
- Initial field GCS 40 – Verbal
- Initial field GCS 40 – Motor
- Pre-existing conditions
- Hospital events

## Other Changes

- All trauma activations do not meet inclusion criteria. Patients with trauma team activations must have a qualifying injury in addition to a trauma activation to meet inclusion criteria.
- Isolated hip fractures added to inclusion criteria.
