Changes to the Wisconsin Tuberculosis (TB) Treatment Assistance Program

Summary

The Wisconsin Tuberculosis (TB) Treatment Assistance Program (WTBTAP) is designed to encourage and support TB clients through the completion of TB treatment by providing funding to purchase treatment assistance aids. WTBTAP is funded by the Centers for Disease Control and Prevention (CDC) and Wisconsin state tax revenue funds. WTBTAP was previously administered by the American Lung Association in Wisconsin and will now be administered through the Wisconsin Department of Health Services, Division of Public Health Tuberculosis Program.

WTBTAP is used primarily for clients who have active TB disease, but can also be used for clients being treated for latent TB infection (LTBI) for encouragement and assistance along the course of their therapy. Local health departments (LHDs) may enroll in the WTBTAP by reading the program guidelines and then completing and signing the WTBTAP Enrollment and Agreement form. Please contact the Wisconsin Tuberculosis Program for more information.

WTBTAP Guidance for LHDs

- Please call the Wisconsin Tuberculosis Program with any questions related to WTBTAP.
- LHDs must review and sign the WTBTAP Enrollment and Agreement form on an annual basis.
- TB treatment assistance aids without pre-approval are capped at:
 - o \$50 for clients being treated for LTBI.
 - o \$200 for clients being treated for active TB disease.
- Table 1 contains a list of allowable treatment assistance aids (included items) and items not covered by the WTBTAP (excluded items).
 - o Purchase of gift cards will only be allowed for establishments where excluded items are NOT available.
 - o Clients receiving gift cards must receive education on allowable purchases (Table 1).
- Treatment assistance above the capped amount must be pre-approved by the Wisconsin Tuberculosis Program.

Gas cards (vouchers)*	Health services (e.g., X-rays)
Flowers	Prescription and over-the-counter medications
Personal care items	Gift cards to establishments where any of
Practical clothing items (less than \$20)	the above can be purchased (e.g., Target, Walgreen's, Visa gift cards, etc.)
Hobby supplies	
Books	
Gift cards to establishments where excluded items are NOT available (limit \$50 per gift card)	

^(*) Gas cards or vouchers must have "for fuel only" imprinted on the card by the company (not hand written).
