It is really up to the EMS medical director for each service to determine the protocol for where to transport patients.         <ul> <li>Medical directors should utilize the state trauma triage plan because it helps designate which patients are appropriate for which level</li> </ul> </li> <li>Might be helpful to lok at data from undesignated facilities including data on trauma, stroke, and cardio</li> </ul>

DHS118 Update	Bill Oemichen	The draft of DHS 118 is being reviewed by the Office of Legal Counsel. DHS is looking to hold at least two hearings on the rule – meetings will likely be in Madison and Wausau this summer. The goal is to have the rule passed by December 31, 2017 and for it to be implemented on July 1, 2018.
