- Waiver (Kev zam) yog ib xuv cai uas cia peb muaj Medicaid cov khoos kas xws li Family Care (Kev Saib Xyuas Kho Mob Tsev Neeg) thiab Family Care Partnership (Kev Koom Tes Saib Xyuas Kho Mob Rau Tsev Neeg).
- Nrog waivers (cov kev zam), peb tuaj yeem pab nyiaj rau cov kev pab cuam kom pab tau cov tswv cuab nyob tau hauv lawv lub tsev.

Kev Txuas Hnub Nyoog Rau Waiver (Kev Zam) Family Care (Kev Saib Xyuas Kho Mob Tsev Neeg) thiab Family Care Partnership (Kev Koom Tes Saib Xyuas Kho Mob Rau Tsev Neeg)

- Cov khoos kas Family Care (Kev Saib Xyuas Kho Mob Tsev Neeg) thiab Family Care Partnership (Kev Koom Tes Saib Xyuas Kho Mob Rau Tsev Neeg) tau txais kev rov txuas sij hawm thiab tau txais kev pom zoo hauv txhua tsib lub xyoos.
 - Ncua sij hawm kev txuas sij hawms tsis ntev los no tshaj plaws: Lub Ib Hlis Ntuj 2020–Lub Kaum Ob Hlis Ntuj 2024
 - Ncua sij hawm txuas sij hawm tom ntej: Lub Ib Hlis Ntuj 2025-Lub Kaum Ob Hlis Ntuj 2029
