

Family Care, Family Care Partnership and PACE Enrollment Data
Monthly snapshot as of October 1, 2014
SUMMARY

The methodology used to sort members into target groups has changed as of the August 2014 reporting period. This report includes any person with an intellectual or development disability in the I/DD target group, regardless of age. Any person with a physical disability is grouped in the PD category regardless of age. Any person age 65 or older, who is not in either the I/DD or PD category, falls into the Frail Elder (FE) category. In reports produced prior to August 2014, any person age 65 or older was reported as a Frail Elder. In order to allow for comparison with earlier reports, a column was added to report members age 65 and older.
