


FoodShare Wisconsin Program at a Glance

All data is for (or as of) the month of January 2010¹


Who receives FoodShare Benefits in Wisconsin?

- **Poverty:** 10% of the 5.6 million people in Wisconsin receive FS.² On average from 1998 - 2000, 8.8% of the state population was at or below the federal poverty rate.³
- **Assistance Groups (AG's)/Individuals:** 314,327 Assistance groups are made up of 704,039 individuals. The AG's count increased by 7,833 from the previous month. There is an average of 2.2 people in an AG.

- **Gender:** 55% of the recipients are female and 45% are male.
- **Adults/Minors:** 55% are adults and 45% are minors. 49% of AG's have minors in them.



- **Minors and Their Parents:** Of the AG's that contain minors, 64% have one parent in the AG, 34% have two parents, and 2% have no parents in the household. "Parent" is defined as a biological or adoptive parent.







- **Parents That Are Minors:** There are 1,275 minors in 1,262 FS AG's that are parents. A slightly higher number than last month and comprises 1/5 of 1 percent of the individuals that receive FS.
- **Case Composition:** The table and graph shows other types of CARES issued assistance that a FS AG receives.




- **Historical Caseload Trend:** The statewide caseload grew last month to over 314 thousand, contributing to a 44% increase over 12 months.




- First Time FS AG's:** This chart shows the number of first-time FS assistance groups over the last 2 years. Only AG's that have never received FS in Wisconsin before the month shown, appear in this chart. In January, 7,766 FS AG's received FS for the first time.



- Age Distribution:** The chart below shows the number of FS recipients by age, in 5 year increments. Children age 4 and under has the largest number for any five year grouping making up 16% of recipients. Half of the recipients are 20 and younger.



- **Elderly/Disabled:** 15% of FS recipients are either elderly, blind, or disabled. 32% of AG's contain at least one individual that is either elderly, blind, or disabled. The average allotment for AG's that contain an elderly, blind, or disabled member is at \$180. However, 16% of the EBD caseload is receiving an allotment of \$20 or less.
- **Work/Earnings:** 38% of the AG's have at least one person working. The average monthly earned income of those AG's' is \$1,217,⁴ an \$2 decrease from last month. 38% of adult FS recipients are employed, the same as last month. Currently, the seasonally adjusted unemployment rate in Wisconsin is 8.7%,⁵ almost double the April 2008 low.




- **Working Families:** A "working family" is defined as a FS AG that contains at least one minor, at least one parent of a minor, and at least one employed recipient. This is an attempt to explore those FS recipients that have children and are working. Working families make up 24% of the statewide FS AG's, average 3.7 persons per AG, and average \$1,413 in earned income per month. Other stats are available below.

- **Allotments:** A total of \$81 million in food stamp benefits were issued for the month. The average allotment amount per AG is \$254.



- **Statewide FS Allotments:** The graph below shows the total dollars in FS allotments spent on all FS AG's statewide for the past two years. Total issuance for this month stands at \$81 million. The large increase in April was due to the Federal stimulus legislation and a change in the allowed income deduction for utility expenses.
