1. Nyeem cov lus nyob ntawm Tshooj Cov Lus Qhia Tseem Ceeb (Important Information section) thiab tas nrho cov lus qhia ua ntej teb cov lus nug hauv cov ntawv thov kev pab.
2. Sau kom pom meej. Siv tus cwj mem xiav los yog dub.
3. Sau cov hnuv rau ntawm MM/DD/YYYY. (Piv txwv: lub 4 Hlis Tim 2, 1958 ces sau 04/02/1958.)
4. Teb cov lus nug txog koj thiab/los yog koj tus txij nkawm.
5. Ua cov ntawv thov kev pab kom tiav txhij txhua. Yog ua tsis tiav yuav tau txais cov kev pab Medicaid qeeb. (Siv Tshooj Txheeb Cov Tshooj Lus thiab Cov Ntaub Ntawv Kom Muaj Txhij (Checklist) nyob phab 15 los pab koj txheeb kom koj paub tseeb tias koj cov ntawv thov kev pab muaj txhij lawm.) COV LUS QHIA TSEEM CEEB (IMPORTANT INFORMATION)

Hnuv Ua Daim Ntawv Thov (Application Date)

Hnuv koj ua daim ntawv thov yog hnuv Medicaid qhov chaw ua hauj lwm txais tau koj daim ntawv thov kev pab uas koj tau kos npe rau. Pab Them Rau Yav Dhau Los (Backdated Coverage)

Tej zaum koj kuj yuav tau txais kev pab Medicaid mus txog 3 lub hlis rau yav dhau los ua ntej hnuv uas koj ua ntawv thov kev pab yog koj muab tau pov thawj txaus tias koj yeej tsim nyog tau txais kev pab Medicaid rau cov hlis ntawd. Yog koj xav tau kev pab them cov nqi kho mob rau ib lub hlis twg hauv 3 lub hlis uas dhau los (backdated coverage) muab Medicaid Daim Ntawv Pab Them Rau Yav Dhau Los “Medicaid Backdated Coverage Request” nyob hauv cov ntawv no los ua kom tiav.

Tus twg yog xav tau Wisconsin Medicaid, tiam sis tsis muab nws tus SSN los yog tsis thov ib tus SSN yuav tsis tau txais cov kev pab, raws li tus cai Wis. Stat. § 49.82(2).
