- Na waydii inaan dib u dhigno dhegaysigaaga ilaa 30 maalmood haddii aad u baahantahay wakhti dheeraad ah si aad u diyaariso dacwadaaga. Si aad u hesho dib u dhigid, la xidhiidh Department of Administration, Division of Hearings and Appeals, PO Box 7875, Madison, WI 53707-7875, ugu yaraan 10 maalmood ka hor dhegaysiga.
- Hek dib u dhigida sabab wanaagsa ah gudaha 10 maalmood laga bilaabo taariikhda dhegaysiga la qorsheeyay addoo la xidhiidhay Division of Hearings and Appeals xaga cinwaanka ku qoran kor.
- Keen markhaatiyadaada.
- Uga dood dacwadaaga si xor ah.
- Waydii caddayn kasta ama warbixinaha la jeediyay ee kugu lidka ah.
- Keen caddayn kasta oo dhagaysiga ah oo taageeri lahayd dacwadaaga.
- Ka aamusnow waxa khuseeya eedaha, maadaama wax kasta oo aad tidhaahdo ama aad saxeexo wax kugu lid loo isticmaali karo gudaha maxkamadda sharciga ah.

**Dhagaysigan kama macnuuco qareenka degmadda inuu dacwad kugu soo oogo ku xad gudubka barnaamijka ula kaca ah gudaha tallaabada maxkamadda madaniga ah ama fal dambiyeed ama wakaaladu inay soo ururiso lacag bixinta dheeraadka ah. Adiga iyo xubnaha qoyska hadhay 18 sanadoo ama ka wayn muddada wakhtiga lacag bixinta dheeraadka waxay ka masuul ahaan doonaan lacag bixinta dheefta khaladka ah ee la bixiyay.**

- Si joogta ah** sababtoo ah tani waxay ahaan lahayd taadii labbaad ee federaalka, gobolka, ama maxkamadda maxaliga ah inaad isticmaashay ama ku heshay dheefaha kala iibsiga ku lugta leh iibka maandooriyaha.

- Si joogta ah** sababtoo ah tani waxay noqon lahayd fal dembi ku helid gudaha federaalka, gobolka, ama maxkamadda maxaliga ah inaad sharci darro uga ganacsatay dheefahan qadar gaadhaya \$500 ama ka badan.
- 10 sanadood** sababtoo ah tani waa taadii u horaysay ama labbaad ee ula kaca ah ahayd cunqabataynta barnaamijka xad gudubka ah oo ay sababtay helida dheefaha labbaad ee ku salaysan warbixinta khiyaamada ah ama metalaada.
