A summary of progress made on the selected objective(s) will be required at project mid-point.

Baseline for Measurement

The Oneida County Health Department WIR benchmark report baseline for measurement is 32%.

The 2015 end of year population based standard benchmark report will be used to determine the baseline for the current adult population based objective.

For the baseline the following parameters will be used to run the benchmark report:

Date of birth range:

19-26 years: 1/1/1989-12/31/1996

greater than or equal to 19 years (Tdap): less than or equal to 12/31/1996 (use 1/1/1900-12/31/1996 in benchmark report)

greater than or equal to 19 years (Influenza): less than or equal to 7/1/1996 (use 1/1/1900-6/30/1996 in benchmark report)

greater than or equal to 60 years: less than or equal to 12/31/1955 (use 1/1/1900-12/31/1955 in benchmark report)

greater than or equal to 65 years: less than or equal to 12/31/1950 (use 1/1/1900-12/31/1950 in benchmark report)

Evaluation date: 1/1/2016 (for Tdap, HPV 3, Zoster and Pneumococcal), 6/30/2015 to assess the 2014-2015 influenza season coverage rates.

Run date: 2/15/2016

Context

Adults will be assessed using the benchmark report for having a dose or doses of PCV 13 and PPSV 23. Progress towards reaching 90% will be measured using a WIR benchmark report. Only adults who have moved out of the agency's jurisdiction may be removed from the cohort for analysis. Unless you can prove that an adult has moved out of your jurisdiction, you cannot remove them from your cohort.

Guidelines for determining increase needed for progress toward contract cycle goals:

20%-29% - 8% above baseline

30%-39% - 7% above baseline

40%-49% - 6% above baseline

50%-59% - 5% above baseline

60%-69% - 4% above baseline

70%-79% - 3% above baseline

80%-85% - 2% above baseline

86%-89% - 1% above baseline

greater than or equal to 90% - maintain

Agencies should consult with their Regional Immunization Representative for assistance with determining activities and interventions that will help them achieve the required increase for their population assessment.

Context Continued

Input Activities

Oneida County will do the following activities:

1. Work with local health providers to establish standing orders for PVC13 and PPSV23 especially focusing on primary care clinics (Aspirus - Woodruff, Three Lakes and Rhinelander, Marshfield Clinic - Woodruff, Marshfield CLinic - Minq. Center, Ministry Medical Group - Rhinelander and Woodruff, VA CLinic - Rhinelander), that serve this population and long-term care facilities (Friendly Villiage and Rehabilitation, Rennes Group, Avanti)
2. Provide up-to-date CDC educational materials on PVC 13 and PPSV23, schedules and importance with local health care providers (mentioned above) in the form of educational packets and mailing notices
3. Collaborate with local health care providers and other health departments to coordinate immunization services for adults
4. Community outreach to local residents through press releases to local radio and television stations, in addition to materials posted on OCHD's website
5. Clean up WIR data
6. Send at least one reminder letter to identified residents in Oneida County eligible for PCV13 and PPSV23.

The Wisconsin Immunization Program recommends the following activities to help ensure the success of this objective:

Coordination of immunization services with other LHDs and/or tribal health clinics.

Sharing information on the Adult Immunization Standards with local health care providers (e.g., during educational sessions or coalition symposiums)

Requesting that adult vaccine doses administered are entered into the WIR

Reminder and recall interventions (e.g., letter, phone call, home visit)
