XI. Council Updates

- Council for Deaf, Hard of Hearing and Deaf-Blind (CDHH) No Council Report to review.
- **Council on Physical Disabilities (CPD)** Ben Barrett stated that CPD has been active and busy distributing the Emergency Preparedness Toolkits and related documents, and focusing energy on this effort.
- Statutory Council on Blindness (SCOB) Rhonda Staats shared that the 2022 Plan of Work for the Wisconsin Statutory Council on Blindness (WSCOB) will be conducting a needs assessment survey for consumers. Currently in the literature review phase, trying to determine what similar efforts came before, and extrapolating data from those efforts. WSCOB will use this data to establish priorities and speak to key state personnel and Wisconsin legislators regarding the needs of Wisconsin residents who live with sight loss.
- Wisconsin Council on Mental Health (WCMH) Kimberlee Coronado shared that she was currently working on Mental Health Block Grant applications and creating strategic plans and priorities. WCMH is working on Equity and Access with Statutory Council on Alcohol and Other Drug Abuse (SCAODA).

XII. Discuss GCPD Membership Recruitment

- David Morstad shared that the Executive Committee will be reviewing Bylaws and recommending updates at an upcoming Bi-Monthly Meeting, to ensure membership compliance.
- The Full membership discussed the fact that there are currently no term limits for GCPD membership, and the importance of all members to re-evaluating membership and participation capacity; and being ok with stepping up or stepping down from GCPD.
