GCPD Bylaws amended April 26, 2018; stated, changes the composition of the Governor's Committee membership to include a majority of people with disabilities (66%) and removes parents and guardians from that percentage.
  - The Executive Committee discussed polling current membership to inquire about disability and to ensure that numbers are accurate.
  - The Executive Committee discussed possibly putting together a GCPD Promotional document to solicit new membership.
