- Discussion included choosing length of video for public release, messaging, and the need to address accessibility in health care beyond current COVID-19 pandemic.
- The Executive Committee specifically discussed with Jeremy Gehler the changes requested to the 8-minute video:
 - Correcting captioning to be grammatically correct and to correct spelling errors.
 - Need to add video and visual captioning added.
 - American Sign Language (ASL) to be added.
 - Possibly translating video to Spanish.
 - Adding a title slide to the beginning of the video.
 - 8-minute video will serve as starting framework for short videos and related editing. The shorter videos will focus on specific issues of concern referenced in vignettes including communication and accommodations.
 - Replace Governor's comments at the beginning of the video with a GCPD member speaking about the video.
 - Also add call to action toward the end of the video by GCPD member.
 - It was proposed that possibly the Chair or Immediate Past Chair could read these new narrative pieces at the beginning and end of the video.
 - GCPD Members' titles in the video need to correctly identify them and their respective roles on GCPD.
 - Goal is to have revised 8-minute video by April 20, 2022
