 - Discussed that if pursuing the GCPD Staff position, the full committee would still need to be active and stay engaged with recommendations and policy.
 - Discussed conducting a survey to Full GCPD Membership to focus on the passion behind the 'why' of being a member of GCPD and level of engagement and commitment they can bring to the Committee.
