This included: Addressing disparities in health care for people with disabilities; Supporting financial and health literacy among people with disabilities; Allowing supporting individuals (paid or unpaid) to be with a person with a disability during medical consultation and treatments; Inclusion of people with disabilities on emergency services panels, particularly with regard to issues that pertain to these populations, e.g., ventilator prioritization; and Access to telehealth care.
  - David Morstad also shared the email response he received from Amber Mullett.
  - The Executive Committee discussed which Executive Committee meeting they should invite Amber Mullett to attend.
- Margaret Kristan stated that it might be good for the Executive Committee to send their recommendations to the full Committee for voting/ranking which GCPD should be prioritizing at this time.
- David Morstad stated that the Executive Committee should draft a letter to the Governor's office with the policy recommendations they sent to Amber Mullett.
