- The Executive Committee also reviewed the additional policy recommendations made at the GCPD Bi-Monthly meeting, which included:
 - o Prioritization of COVID-19 vaccinations
 - Rapid COVID testing and false positives this is delaying surgeries and needed medical treatment for people with disabilities.
 - COVID testing sites and tests not accessible to the majority of people with disabilities, especially if homebound.
 - Information provided by state and others needing to be accessible to all people with disabilities.
 - Ramsey Lee commented that the caregiver shortage has been made worse by the pandemic.

- After reviewing all the policy recommendations, David Morstad asked Executive Committee members as to what policy recommendations should be included in the letter to the Governor.
- Margaret Kristan stated that she felt the policy recommendation related to COVID-19 should be at the top of list and feel the most urgent.
 - Nancy Leipzig agreed with Margaret Kristan's recommendations.
 - David Morstad summarized the policy concerns and recommendations to be included in the letter to the Governor's office are as follows:
 - Testing accessibility;
 - Information being available in accessible formats; and
 - Plan for homebound people to get access to tests and vaccinations.
 - Nancy Leipzig will draft the letter to the Governor outlining GCPD's policy concerns and recommendations related to COVID-19 for people with disabilities by the November 5, 2020 Executive Committee meeting. See Action Item 3.
 - The Executive Committee also discussed continuing to meet weekly through the end of the calendar year and then reevaluating this meeting schedule in 2021.
 - DHS support staff will send weekly Executive Committee meeting calendar invites through the end of 2020. See Action Item 4.
