  - Discuss the Recommendation for Americans with Disabilities Act (ADA) Coordinator Position within Government
    - The Sub-Committee discussed a one-page recommendation from GCPD to support an ADA Coordinator position or an equivalent to work within DHS.
      - This position was previously held within Department of Administration (DOA), and it focused more on physical access, however, based on the pandemic, a need for digital access is important. This position title is generic and can be broadened.
      - Discussed the need for access to be a part of everyone's job description and leadership needs to continue to move it forward and accept that there will be times of failure and learning and improving.
      - Laura Plummer shared links to the <u>Accessibility Guide A</u> toolkit for accessible communications in the workplace (mo.gov) and <u>State Policy | Section508.gov</u>.

#### VII. Access to Voting in Wisconsin Presentation

- Barbara Beckert, Director of External Advocacy, Disability Rights Wisconsin (DRW) attended the Sub-Committee Meeting and discussed feedback on accessible concerns and advocacy efforts from the 2022 elections.
  - Wisconsin Election Commission just had their meeting and certified the election results as well as had public comments regarding access, and the meeting log will be sent out to the Sub-Committee for review.
  - DRW has a voter hotline and some concerns included: issues with correct information not being given regarding having the right for ballot return assistance; lack of resources for transpiration for individuals in rural and some urban settings; some Indefinitely Confined Voter ballots were not sent out; not all accessible voting equipment was fully accessible; guardianship and voting rights; parking access issues, lack of signage, and physical access to voting locations.
